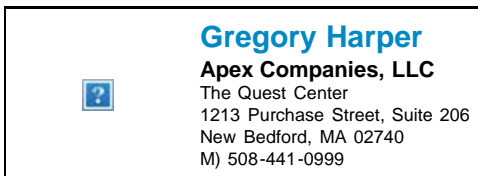

Eric and I just talked with Ed Bell at MHC. It does not appear that he has any concerns with the Lighthouse. He did have questions about potential impacts to the paleosols and whether the modifications described in the May 20, 2013 letter to EPA had been surveyed for paleosols. We informed him it had been and he was greatly relieved (his words). He then asked for a GIS/satellite map showing the pre and post May 20 outlines of the project and the locations of the paleosols as well as a cover letter from Apex that the surveys are complete in all relevant areas.

We are working on assembling that information so that I can hand deliver to Ed this afternoon.
