### **EPA CONDUCTS** PLANNING WITH US ARMY CORPS OF ENGINEERS

Demonstrating our commitment to developing a Removal Project at the BoRit Asbestos Area site that incorporates suggestions from the BoRit Community Advisory Group, EPA has divided the work to be done onsite into distinct phases. The Agency has decided to proceed carefully with this project. EPA consulted with USACE hydrological experts and local municipal stream bank removal project needed to be carefully planned in order to contain and control surface water coming through Rose Valley Creek and Tannery Run which both have flooded low lying sections of Ambler Borough and Whitpain Township in the past. EPA is concentrating the remainder of this construction season to the stabilization of the of Wissahickon Creek bank adjacent to the park.

# Health agencies release report on EPA's 2006-2007 air sampling data

The Pennsylvania Department of Health and the Federal Agency for Toxic Substances and Disease Registry jointly released a health consultation which evaluates the air sampling data EPA collected from April 2006 until November 2007. Health officials concluded that, based on the 2006-2007 air sampling results, exposures to airborne asbestos levels at or near the BoRit Asbestos Area Site are not expected to cause harmful health effects for the public. They also concluded that activities that significantly disrupt the surface of the site pose a potential public health risk. The public is encouraged to read the health consultation and make comments during a 45-day public comment period. A copy of the document is online at www.EPAOSC.net/BoRit.
