#### Introduction to the Collection

This is the Administrative Record for the New Bedford Harbor Superfund site, New Bedford, MA, Operable Unit 2 - Hot Spot, Final Explanation of Significant Differences (1995 Hot Spot ESD). This Administrative Record was established on October 30, 1995 and subsequently released on CD-ROM in September 2008. This index was amended in September 2008 to reflect that EPA added records to the Administrative Record that had been inadvertently omitted; the additional documents are listed on the attached September 2008 Amended Administrative Record Index Sheet Additional Document List for the New Bedford Harbor Superfund Site Operable Unit 2 - Hot Spot, Final Explanation of Significant Differences (1995 Hot Spot ESD). This Administrative Record modifies the 1990 Hot Spot Record of Decision for the New Bedford Harbor Superfund Site established on April 6, 1990 and contains site-specific documents used by EPA staff in modifying the response action at the site.

This Record incorporates, by reference, the Administrative Record for the New Bedford Harbor Superfund site Operable Unit 2 - Hot Spot Record of Decision (1990 Hot Spot ROD), including the Administrative Record for the Explanation of Significant Differences for Final Disposal of Ash (1992 Hot Spot ESD) and the Administrative Record File compiled as of the February 2, 1993 update, as amended, September 2008 for the New Bedford Harbor Superfund Site Operable Unit 1 - Upper and Lower Harbor (formerly named Estuary, Lower Harbor/Bay Operable Unit). The Administrative Record File indices for the amended February 2, 1993 Update and the September 28, 1990, January 30, 1992, May 13, 1992, and Amended July 2, 1992 Updates that preceded it are provided with this 1995 Hot Spot ESD. Note that all documents listed in these updated indices have been incorporated into the Administrative Record for the New Bedford Harbor Superfund site, Operable Unit 1 - Upper and Lower Harbor Record of Decision.
