We are yielding answers in the order requested.

1. Waterrrest Products, Inc. First occuppied the site 11/78.

4. No manufactured products or process.

5. We retail waterbeds and bedroom furniture. To prevent the growth of algae and condition the vinyl of the mattress against cracking, we sell a "Multi-purpose conditioner", as follows:

Generic Name: Unknown to us. (We purchase in plastic bottles for resale. No processing done by us).

6a. During the period of time to May, 1979 we purchased these chemicals from Blue Magic Products, Box 4175, Stockton, CA.

Un the number purchased, we shall estimate we sell 400-600 beds each month and a bottle of Algae Conditioner for each bed. The life of the chemical ranges from six months to 24 months inside the mattress.
