KENT — No one can refuse a juicy scoop of strawberries on a sizzling Saturday afternoon, especially when it is cooled with some vanilla ice cream.


Certainly the children outside the First Congregational Church on June 14 could not move three steps away from their bowls full of chocolatecoated strawberries, shortcake and ice cream.

According to one of the volunteers, Nancy Preston, the festival is not only delicious, but also "very traditional." It began sometime in the 1950s or 1960s, and Preston helped revive the tradition four years ago to "sup-

PUBLIC NOTICE AND OPPORTUNITY TO COMMENT

The U.S. Environmental Protection Agency (EPA) announces that it is seeking public comment on a Proposed Remedial Action (also known as the proposed cleanup plan), for the Housatonic River "Rest of River." The pro posed cleanup plan, which consists of a Draft Modification of the Reissued RCRA Permit, and a Statement of Basis, covers the "Rest of River" portion of the GE-Pittsfield/Housatonic River Site and addresses the river's sediment and floodplain PCB contamination beginning in Pittsfield, MA and extending into CT. Interested persons can submit written comments to EPA on the Proposed Cleanup Plan from June 25, 2014 through August 8, 2014.

The proposed cleanup plan is available on-line at www.epa.gov/region1/ge and copies of the Statement of Basis are available at most town halls in CT & MA along the Housatonic River. The public comment period is June 25 - August 8, 2014, and a Public Hearing date will be scheduled where the public will have an opportunity to make oral comments for EPA to consider. Details about how to submit comments are in the plan and on the website.

Prior to the start of the public comment period, EPA will hold two public information sessions to share the plan with the public. Both meetings will begin at 6 pm with a poster session, followed at 7 pm by a presentation and question and answer period.

The first meeting will be held on Wednesday, June 18th at the Lenox Memorial Middle and High School auditorium, 197 East Street in Lenox, MA. The second meeting will be held on **Tuesday, June 24th at the Kent Town** Hall, 41 Kent Green Blvd in Kent, CT.
