AFFIDAVIT

NOW COMES, Stacy Krantz, of the City of Midland,
County of Midland, State of Michigan, being duly sworn,
deposes and says:

1. That I am currently employed by The Dow Chemical
Company in Midland, Michigan as a Senior Product
Specialist.

2. That I have been employed by The Dow Chemical
Company since 1959.

3. That during the time period 1973 to 1980 I was a
Senior Product Representative for Dow Latex Products.

4. From 1973 until 1980 I was kept informed of
Stecher - Traung & Schmidt Corporation's (STS) purchases
of Dow CP 620 A Latex. It was and continues to be my
responsibility to project and plan future production runs
based on the needs and demands of our customers which, at
the time, included STS.

5. That while I was a Senior Product
Representative, The Dow Chemical Company sold Dow Latex
620 (later renumbered, without any change in formula, to
CP 620 A) to STS at their Rochester, New York plant.

6. That to the best of my knowledge, information
and belief in 1973 The Dow Chemical Company sold CP 620 A
Latex (previously known as Dow Latex 620) to STS at their
Rochester, New York plant. This being the same and only
product that I recall The Dow Chemical Company selling to
STS at their Rochester, New York plant.

7. That I have attached and incorporated into this
Affidavit a Material Safety Data Sheet (MSDS) and sales
specification sheet prepared by The Dow Chemical Company
for Dow CP 620 A (previously known as Dow Latex 620).

8. That The Dow Chemical Company, because of its records retention program, does not possess any records dating back to the time period in question: 1973 to 1980.


9. That Dow Latex CP 620 A is a non-hazardous waste as defined by § 3001 of the Resource Conservation and Recovery Act (RCRA) and a non-hazardous substance as defined by §§ 101(14), 102 of the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA).
