Subject Myers Property Site - Drum Restaging

Dear Mr. Prince:

This letter is submitted to document the staging of waste drums generated in September 1989 during supplemental field activities performed in support of the Myers Property Site Feasibility Study (FS).

The subject drums contained various waste materials (monitor well purge water, disposable equipment/health and safety gear, and decontamination fluid and equipment) resulting from field activities. A number of empty (unused) drums were also left over from the field work.

On 27 September 1989, a WESTON field crew went to the site for the purpose of restaging the drums in a secure and unobtrusive fashion, pending determination as to their ultimate disposition. It was intended that these drums be staged in the on-site warehouse near those drums previously staged therein following the Remedial Investigation (RI).

The field team performed a count and external inspection of the drums, which were located at various locations (near sampling points) around the site. A total of 45 drums were found. Attachment 1 provides the drum inventory obtained by the field crew. All drums appeared intact and no problems with drum condition were noted.

All 45 drums were staged in the warehouse, adjacent to those remaining from the RI. Due to a problem with the strength of the pallets, some of which broke in handling the drums, it was not possible to stack pallets two deep as was intended. The drums were therefore staged in a single layer on the floor. The drums were, however, staged in such a way as to maintain a clear path to the

warehouse door and no problems with clearance are foreseen.

The crew finished staging drums in the afternoon on 27 September 1989. They subsequently cleaned up, closed and locked the site gate, leaving one closed drum containing their disposable gear immediately inside the gate.
