Enclosed is a copy of the February 1999 draft Health Consultation report for the Hudson River PCB Superfund Site. This draft report was developed by the New York State Department of Health (NYS DOH), in cooperation with the U S Agency for Toxic Substances and Disease Registry (ATSDR). This report compares and discusses the results of two surveys of anglers fishing on the Hudson River. Anglers fishing on 172 miles of the Hudson River between Hudson Falls and the Tappan Zee Bridge were interviewed in 1996 using the same questionnaire which was used in 1991-92 by the Hudson River Sloop Clearwater. The 1996 survey found that more anglers fishing in the Upper Hudson River (Hudson Falls to Troy) were aware of the health advisories and fewer said they ate the fish. However, in the area south of Catskill, more than two-thirds of anglers were not aware of the advisories and some anglers said they were eating, sharing and giving away fish that they caught.

In October 1998, the US Environmental Protection Agency committed funds of \$173,000 to the state to inform anglers and others who eat fish from the Hudson River and New York Harbor about the health advisories. NYS DOH has begun by working with community and environmental groups, anglers, local governments and state and federal agencies to identify effective ways to provide health information about the fish advisories. Focus groups were held to field test signs that will be posted along the Hudson River, as well as contacting marina operators and others to enlist their support in posting the signs. A public service announcement will be developed to air on radio stations along the Hudson River and "River Rangers" will visit fishing access sites along the Hudson River to raise awareness about the health advisories.

Citizens' questions and comments are an important part of the review process and we encourage you to read the document carefully. Please send us your comments by **April 15, 1999**, so that they can be considered as the public health consultation is finalized. Enclosed is a reply form for your use.
