

RESOLUTION NO. 76 OF 1990

Resolution introduced by Supervisors Lilac, Hathaway, Marchione, Sgambati, Seymour, Daubney and MacDonald.

IN OPPOSITION TO THE DREDGING OF THE HUDSON RIVER.

WHEREAS, the New York State Department of Environmental Conservation recently released its Hudson River PCB Project "Action Plan"; and

WHEREAS, this "Action Plan" is far more comprehensive than an earlier plan and now seeks to dreage the Hudson River flowing through a vast area of Saratoga County; and

WHEREAS, recent documentation by the Department of Environmental Conservation demonstrates a vast reduction in the amount of PCB's in certain types of fish; and

WHEREAS, this recent documentation is proof that the Hudson River is cleansing itself; and

WHEREAS, the residents of Saratoga County have been unable to fully utilize the beautiful natural resource facility known as the Hudson River for several years; and

WHEREAS, this Board of Supervisors is concerned that there is no suitable environmentally safe method of disposing of the PCB's during and after the dredging process; and

WHEREAS, it is the belief of this Board that any type of dredging of this chemical from the bottom of the Hudson River will only cause the stirring-up of this chemical, thus destroying the naturally occurring biodegrading of PCB's; and

WHEREAS, the General Electric Company has discovered a possible alternative to the dredging proposal in the form of a chemical process which would act as a catalyst in speeding up the biodegrading of PCB's; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors voices strong opposition to any dredging of the Hudson River and urges the New York State Department of Environmental Conservation to work with the General Electric Company to arrive at a suitable alternative to the dredging proposal; and be it further

RESOLVED, that the Clerk of this Board of Supervisors is directed to send a copy of this Resolution to the following:

RESOLUTION NO. 77 OF 1990

Resolution introduced by Supervisors Reib, Hunter, Klein, Lilac, McDonald, Seymour and Sullivan.

OPPOSING THE 1990 ENVIRONMENTAL QUALITY BOND ACT.

WHEREAS, the Governor of the State of New York has called for the passage of a 1.9 Billion Dollar Environmental Quality Bond Act; and

WHEREAS, the proposed Environmental Bond Act would have the dual purposes of allocating funds for the purchase of land within the Catskills and Adirondack Parks as well as providing local municipalities with funding for their solid waste programs, and

WHEREAS, this Bond proposal combines two purposes and such a combination is contrary to the New York State Constitution, and

WHEREAS, the Constitutional prohibition against dual purposes in a single Bond Act is intended to protect citizens who wish to vote in favor of one purpose and not the other, and

WHEREAS, said proposed Environmental Bond Act denies such right to the citizens of the State of New York, and


WHEREAS, while this Board of Supervisors recognizes the vital importance of the solid waste component, it strongly objects to any further land acquisition within the Adirondack Park and the consequential imposition of regulations upon the citizens living therein; now, therefore, be it

RESOLVED, that this Board of Supervisors objects to the acquisition of more state lands within the Adirondack Park and therefore, opposes the 1.9 Billion Dollar Environmental Bond Act, and be it further


RESOLVED, that the Board of Supervisors believes that the State of New York has an obligation to assist local municipalities with their solid waste programs, and be it further
