RESOLUTION #138-97

TO SUPPORT A COUNTY LAW TO PROHIBIT A PCB LANDFILL WITHIN WASHINGTON COUNTY

WHEREAS, the Town Board of the Town of Easton has gone on record to oppose the dredging of PCBs from the Hudson River, and

WHEREAS, the EPA has conducted a PCB landfill siting study, and

WHEREAS, areas in all of the Washington County Towns along the Hudson River corridor have been pin pointed as potential landfill sites, and

WHEREAS, the Washington County Board of Supervisors has proposed drafting a county law prohibiting the landfilling of PCBs within its borders, and

WHEREAS, the Washington County Board of Supervisors has determined that dredging the PCBs is unnecessary, Now, Therefore, Be it

RESOLVED that the Town Board of the Town of Easton supports and encourages the Washington County Board of Supervisor's efforts to adopt a local law prohibiting the siting of a PCB landfill in Washington County, and be it further

RESOLVED that the Easton Town Board does hereby encourage each of the towns in Washington County to officially support a county law prohibiting a PCB landfill, and be it further

RESOLVED that the Easton Town Board also encourages each of the towns in Washington County to examine their current no dumping laws and strengthen them to exclude PCBs specifically, and be it further

RESOLVED that copies of this resolution be sent to Carrie Whitney, Washington County Clerk to the Board of Supervisors, each Town Supervisor, Governor George E. Pataki, Congressman Gerald Soloman, Senator Ronald Stafford, Assemblyman Robert D'Andrea, the EPA and NYSDEC Commissioner Cahill.
