**CHANGE IN INFORMATION REPOSITORY LOCATIONS FOR
HUDSON RIVER PCBs REASSESSMENT DOCUMENTS**

The U.S. Environmental Protection Agency, Region 2, has announced that the location of two (2) of its fifteen (15) Information Repositories for documents pertaining to the Hudson River PCBs reassessment have been changed as follows:

The repository formerly established at the Ft. Edward Town Clerk's Office in the Ft. Edward Town Hall at 118 Broadway in Ft. Edward, NY has been relocated to the Saratoga County Environmental Management Council, 50 West High Street, Ballston Spa, NY 12020. The contact there is George Hodgson.

The repository formerly established at the SUNY Campus in Building 40 in Stony Brook, NY has been relocated to the Cornell Cooperative Extension, Ulster County, Sea Grant Extension Program, 74 John Street, Kingston, NY 12401. The contact there is Bob Linck.

These repositories are up and running and ready to receive members of the public who seek to review the documents pertaining to the EPA's Reassessment of the Hudson River PCBs Superfund site.

We wish to thank the Cornell Cooperative Extension of Ulster County and the Sea Grant Program as well as the Saratoga County Environmental Management Council for graciously acting as custodians to these important document centers. As previously mentioned, EPA has established a total of fifteen Information Repositories for this site throughout the Hudson Valley. This was done in consideration of the large geographic area covered by the site (some 200 river miles), as well as the high level of public interest in the issue of PCBs in the Hudson River. A complete listing of all information repositories for this site is printed on the back of this page.

Please note that at this time, EPA is exploring the siting of an additional repository in the Ossining/Peekskill area, since the repository at the Croton Free Library is incomplete and can not continue in this capacity due to a lack of space. We will notify you when a new location is established.
