Directions to the Hudson River PCBs Oversight Committee Meeting

From the Taconic State Parkway:

Exit at Route 44 or 55 and proceed west. In Poughkeepsie, these two routes merge; continue west on Route 44/55 for about two miles to Route 9. Drive north on Route 9 toward Hyde Park about one mile; the campus will be on your left.

From the New York State Thruway:

Use Exit 18 (New Paltz). Go east on Route 299, then south on Route 9W. Cross the Mid-Hudson Bridge to Poughkeepsie and follow the signs to Route 9 North toward Hyde Park. Drive north on Route 9 about one mile.

To the Campus Center Building:

Enter the campus at the main entrance. Proceed into the campus and make a left hand turn into the Champagnat Parking area (indicated as # 7 on the campus map). The Campus Center Building is at the far (south) end of the parking lot (indicated as #5 on the campus map).

Marist College is also accessible by train. The Poughkeepsie Train Station, servicing both Metro-North and Amtrak, is less than one mile south of the campus.
