The EPA is proposing to modify the September 29, 1995, Record of Decision (ROD) for cleanup of the groundwater component, referred to as Operable Unit One (OU1) of the AIW Frank Superfund Site. The Site is located in West Whiteland, Chester County, Pennsylvania, approximately one mile east of Exton on Lincoln Highway, US Business Route 30.

What is EPA Proposing?

EPA is proposing to change the groundwater remedy selected in the 1995 ROD from a remedy combining groundwater extraction, treatment and institutional controls to a remedy that combines :

- in situ chemical oxidation (ISCO),
- bioremediation,
- long-term monitoring, and
- institutional controls.

Other modifications include:

- addition of 1,4-dioxane to the list of contaminants of concern (COCs)
- addition of Pennsylvania's Act 2 cleanup standards and
- Addition of EPA's May 2014 Guidance for Evaluating Completion of Groundwater Restoration Remedial Action to the statutes, regulations and policies considered in the implementation of the remedial action at OU-1.

In situ chemical oxidation (ISCO) involves injecting an oxidant, such as postassium permanganate, into the groundwater to treat VOCs and 1, 4-dioxane. Following ISCO, enhanced bioremediation will involve injecting nutrients and other amendments into the groundwater to enhance degradation of the contaminants.

After reviewing several treatment options and determining that the modified remedy will be more effective than the current remedy in addressing groundwater contamination at the Site, EPA proposes the modifications as the final OU-1 remedy for the Site. The Commonwealth of Pennsylvania supports EPA's proposal, pending public comment.
