# **Sharon Steel Farrell Works Disposal Area Superfund Site: REMEDIAL ACTION START**

#### What is the Remedial Action?

Beginning in October 2018 and continuing through February 2021, a U.S. Army Corps of Engineers environmental contractor will construct a cap in the northern portion of the Sharon Steel Farrell Works Disposal Areas Superfund Site, located at 300 Ohio Street. Most of the work will be north of Ohio Street and includes relocation of steel-making sludge and slag and construction of a biosolids-enhanced cap, as well as erosion control measures, stream bank restoration, and construction of a wetlands next to the Shenango River. The EPA and U.S. Army Corps' Pittsburgh District

entered into an agreement under which the U.S. Army Corps will award and oversee the construction. EPA will monitor the work.

### What you will see when the project starts?

The work will include site set-up and some excavation and grading. The work will start this fall and shut down for the winter. Work will be conducted between 7:00 am and 5:00 pm, Monday through Friday, and possibly some Saturdays.
