- 5. The Stearns & Foster Bedding Company does not have reason to believe that any waste material generated or disposed of by it was disposed of at the Site.
- 7. The Stearns & Foster Bedding Company facilities located in Lockland and Mason, Ohio did not produce hazardous waste. Prior to August 1985, The Stearns & Foster Bedding Company operated a Textile Division at the Lockland, Ohio facility. (See response #10(d)(1)(e)). The company is without information to respond to this Request for Information with respect to the Textile Division. (See response #3)

Between approximately 1971 and 1980 the company operated a

facility in Mason, Ohio. The company assembled mattresses and box springs as well as upholstered furniture at the Mason, Ohio facility.

LSF Manufacturing Co. (see response #10 (a)) operated in Mason, Ohio from 1978 to 1986 at which time it was merged with the company (see response #10 (d)(1)(f)) and its operations were transferred to Lockland. Its operation generated waste of polyurethane foam.

Respondent's financial statements on a separate basis for fiscal year 1990 are not available. The financial information provided herein represents separate financial information for The Stearns & Foster Bedding Company and for The Stearns & Foster Upholstery Furniture Company and for The Stearns & Foster Upholstery Furniture Company.

b) April 6, 1984 - purchase of Lifetime by The Ohio Mattress Company from Sears Roebuck and Co. The Lockland, Ohio and former Mason, Ohio mattress, box spring and upholstered furniture assembly facilities to which this information request appears to be directed were not owned by Lifetime. Lockland and Mason were owned by The Stearns & Foster Company. Therefore, pre 1984 ownership change information regarding Lifetime is not provided herein.

c) December 1984 - establishment of "The Stearns and Foster Upholstery Furniture Company" a wholly owned subsidiary of The Stearns and Foster Bedding Company.

d) March 22, 1985 - sale of Carson-Saeks Division of The Stearns & Foster Technical Textiles Company to WDS Acquisition Co.

e) August 30, 1985 - sale of the Textile Division.

f) September 29, 1986 - merger of LSF Manufacturing, Inc. into The Stearns & Foster Bedding Company.

g) April 24, 1989 - tender offer for 96% of the stock of The Ohio Mattress Company. August 9, 1989

- merger of GGvA Acquisition Corp. into The Ohio Mattress Company (see enclosed prospectus dated August 18, 1989). GGvA Holding Corp. is now named Sealy Holdings, Inc. The Ohio Mattress Company is now named Sealy Corporation.

2) The Stearns & Foster Company:

a) 1978 - The Stearns & Foster Company acquired 50% of L & L Investments Inc. from Lifetime Foam Products Inc. On July 7, 1978, L & L Investments changed its name to LSF Manufacturing Co. In 1984, The Stearns & Foster Company acquired the remaining 50% of LSF Manufacturing Co. The agreements documenting acquisition of these ownership interests have not been located.

b) December 3, 1984 - merger between Lifetime Foam Products, Inc. ("Lifetime") and The Stearns & Foster Company and name change of surviving corporation to "The Stearns & Foster Bedding Company".

c) December 22, 1983 - purchase of The Stearns & Foster Company by Ohio-Sealy Mattress Manufacturing Company.
