Dear Mr. Jouras:

Pursuant to conditions specified in a permit (see attached) issued by the City of Chicago, radiation monitoring was required to be performed at the above referenced site. AECOM Technical Services, Inc. (AECOM) provided the required radiation surveillance on February 16, 2015 for an excavation to decommission an existing gas service line located at 224 East Ontario Street.

Surveying was performed on both the soil removed from a 3-foot by 5-foot trench and within the in the roadway of East Ontario Street, south of the permitted address (see sketch). The maximum depth of the excavation was approximately 4-feet below ground surface. Backfill in the vicinity of the gas main was primarily clean tan sand above areas of the existing gas service utility encountered within the excavation. The monitoring revealed no indication of fill soil above the clean-up value established by the U. S. Environmental Protection Agency (USEPA) for the Streeterville area of Chicago. The USEPA cleanup value for Chicago's Streeterville area is 7.1 picocuries per gram (pCi/g) total radium (Ra-226 + Ra-228).

Gamma radiation count measurements for the project were made using Ludlum Model 2221 survey meter and an unshielded 2 x 2 inch Nal probe (Model 44-10). For the instrument used, the gamma count threshold equivalent to the 7.1 pCi/g cleanup value is 18,279 counts per minute (cpm) unshielded (6,282 cpm shielded). The field gamma background for the area was measured at approximately 6,498 cpm unshielded as measured at the exposed soil within a tree planter near the vicinity of the excavation at the permitted address.

The field gamma measurements within the excavation during the excavation process did not exceed the instrument threshold previously stated and ranged from a minimum of 6,200 cpm to a maximum of 7,500 cpm unshielded. Thus, there was no indication of the presence of radiologically-contaminated material and/or an exceedance of the USEPA cleanup value of 7.1 pCi/g total radium. A copy of the permit and a field sketch documenting the area where work was performed have been included as attachments.

Restrictions:

- 1. A copy of the permit must remain on-site for inspector's review.
- 2. Permit fees must be paid within 24 hours of the date of issuance. Failure to pay will result in you being considered in violation of the terms and agreement of the permit and subject to any applicable fine and fees as if you never attained a permit. Additionally, you will still be responsible for the cost of the original permit. Monthly billing accounts are not applicable to the 24 hour payment criteria but failure to pay the monthly bill by the due date will result in the same penalties applying.
- 3. All directional boring must be pre-approved by the Office of Underground Coordination.
- 4. Contractor must secure plating over all openings in the roadway and secure all sidewalk/parkway openings during non-working hours until such time when the road surface is restored.
- 5. All traffic control will be the responsibility of the contractor and must comply with all MUTCD standards.
- 6. Work permitted only between
- 7. Restore all lanes to normal operation during non-working hours.
- 8. Must use flagmen and/or arrow boards to maintain traffic operations through the work zone.
- 9. Contractor must notify DIGGER at 312-744-7000 no less then 48 hours (exclusive of Saturdays, Sundays and Holidays) but no more then 14 calendar days in advance of the start of the excavation or demolition, unless the excavation date was provided with the application and remains unchanged. Prior to 26 calendar days the Contractor must notify DIGGER to renewal the dig date!
- 10. It is the Excavator's responsibility to request refreshing of marks when needed, but no longer than 28 calendar days after the last requested date.
- 11. When applicable, all excavation areas are to be clearly marked in safety white paint prior to calling DIGGER. White paint is not required for joint meets or emergency work.
- 12. Excavators requesting dig tickets are responsible for the protection of utility markings at the job site. Any markings of underground utilities utilizing utility colors, must be done by facility owners or authorized agents only.
- 13. Pursuit to City Ordinances 8-32-140 through 170 use of pneumatic equipment must not begin before 8:00 A.M. or continue after 8:00 P.M.
- 14. Permittee must provide a sign which identifies the telephone number and company or person performing the work. Signage may be affixed to barricades.
- 15. Permanent base pavement restoration to follow within 5 days after the completion of underground work.
