Dear Mr. Jouras:

An emergency repair of a gas leak was conducted in the early evening of Wednesday January 18, 2017. The repair was performed at the above address in the sidewalk near the Red Roof Inn at the corner of N. St Clair and E. Ontario Streets. A copy of the emergency permit (No. 600211347) is attached along with the Chicago Department of Public Health (CDPH) form. On Thursday January 19, 2017, I spoke with a member of the crew that had made the repair. It was indicated that the repair work involved the excavation of a small 5x5 foot opening to a depth of between 3 and 3.5 ft. The only material encountered in the excavation was clean tan sand backfill that had been placed in the excavation when the service was originally installed. Given that this was clean backfill sand, it would not contain thorium contamination. The crew member also indicated that the excavated clean sand was backfilled into the excavation Wednesday evening after the repairs were completed. Therefore, gamma screening of the clean backfill sand that was encountered did not appear warranted. An email describing the emergency repair activities was forwarded to Ms. Verneta Simon (USEPA).
