The U.S. Environmental Protection Agency (EPA) is supporting the development of a Superfund community advisory group or CAG. A CAG allows people in the community to provide coordinated, local input to the decision-making process at Superfund sites. It is a forum for members to present and discuss community needs and concerns related to Superfund cleanup projects and explore areas of common ground in the community. A CAG assists EPA in making better decisions by providing the Agency a unique opportunity to hear and seriously consider community preferences for site cleanups. The CAG does not replace other forms of community involvement and the CAG will be expected to work closely with the broader community throughout its process.

Membership in the CAG will consist of 15 to 20 local residents representing a wide range of backgrounds, interests, and viewpoints. Members will be chosen by a committee of local community members based on information provided in the applications received.

Expectations of CAG Members

Membership on the CAG will be hard work. Members will be expected to attend all monthly meetings, participate in subcommittees, read materials and background information between meetings, and help to communicate with neighbors and others in the community. In addition, the CAG will seek to find common ground where possible, requiring all members to approach each other with respect and all issues with an open mind. Total time commitment is expected to be approximately 6 - 8 hours per month.
