Dear Mr. Prasad:

At approximately 8AM on December 8, 2021, an emergency dig number (#601112501) was requested for a gas leak at the above referenced address. The emergency work was required to removed surficial pavement to get access to the valve box cover where the shutoff valve was located. The valve box cover had apparently been paved over at some point in the past. This required the removal of the upper portion of the pavement to uncover the top of the box and reach the shut-off valve. The pavement removal did not involve disturbing or exposing urban fill (i.e., the full depth of the pavement was not removed). The valve box location was expected to be within a few inches of the pavement surface. AECOM placed a call in the morning to CDPH to inform them on the progress of the work. Specifically, that the work was going to be accomplished without disturbing or exposing urban fill.

Partial surficial pavement removal was conducted in two 4 by 6-foot areas. The first area of surficial pavement removal was 150-feet west of property line on the western side of N. McClurg Ct. and 33-feet north of the property line on the south side of E. Illinois St. (refer to the attached photographs). The valve box was not observed in this area, so pavement was removed in a second area slightly (10-feet) east of the first. This second area was 140-feet west of property line on the western side of N. McClurg Ct. and 33-feet north of the property line on the south side of E. Illinois St. The valve box was located 6-7 inches below the pavement surface. The pavement (concrete and asphalt) is approximately 12-inches or more thick in this area. Therefore, the pavement removal did not involve disturbing or exposing urban. Thorium monitoring was not necessary to complete the work since it did not expose or excavate urban fill materials. Both of the areas were resurfaced that same afternoon.

As part of the permit conditions, a PDF copy of this letter will be forwarded via email to Ahmad Nur and Terry Sheahan (CDPH), as well as Verneta Simon (USEPA). This letter includes a copy of the CDOT permit and CDPH ROW form which was completed/issued following the completion of the emergency work. Also included in the attachments are a photograph (looking northwest) taken as the repaving work was being completed and a second image, looking south, that shows the store fronts south of the work area. Reiterating, the work did not require removal of the complete depth of pavement or expose underlying urban fill, so no thorium monitoring was required.

Restrictions:

- 1. Contractor, sub-contractor or the entity performing the work shall remove all temporary parking restriction signs upon completion of the work
- 2. Every person who engages in non-emergency excavation or demolition shall provide notice through 811 Chicago to the persons who own and operate the underground facilities in and near the excavation or demolition area, not less than 48 hours (exclusive of Saturdays, Sundays, and Holidays), but no more than 14 calendar days, in advance of the start of the excavation or demolition. Please review Municipal Code of Chicago § 10-21 and the Excavator Handbook (posted on <u>811 Chicago's website</u>) for additional information related to Chicago's one-call regulations, including outlining the dig site, extending dig tickets, and remarking work sites.
- 3. A copy of the permit must remain on-site 24 hours per day for inspector's review. Posting a copy on barricades is acceptable.
- 4. Permittee must provide a sign which identifies the telephone number and company or person performing the work. Signage may be affixed to barricades.
- 5. At least 3 of 4 corners at any intersection must be accessible at all times
- 6. To have no-parking signs REPOSTED if torn down call 312-747-5085 and provide your service request number (SR#)
- 7. All work shall be in accordance with CDOT Rules and Regulations for Construction in the Public Way and City of Chicago Municipal Code. Work to be performed as per plans and specifications. All traffic control will be the responsibility of the contractor, and must comply with all CDOT and MUTCD standards.
- 8. Contractor must secure plating over all openings in the roadway and secure all sidewalk/parkway openings during non-working hours until such time when the road surface is restored.
- 9. Start Time no Earlier than 9:30am End Time no Later than 3:30pm
- 10. No work in or use of the public right of way is to be done when a special event is taking place. It is up to the applicant to determine if an event is scheduled. To obtain a listing of programs or events within the City of Chicago, please dial 311 when you are within the City boundaries.
- 11. If the activity authorized by this permit is associated with an approved OUC project (as noted above), then all applicants—including the permittee and subcontractors—agree to abide by the comments and conditions posted by each OUC member in the "transmittal review form."
