Recent Activities

- As the site team continues its investigations, it has learned that a number of anticipated early interim actions in the mining district are likely to be completed by private property owners or the Federal land management agencies. EPA had planned to seek public comment on eight proposed early interim actions this year. However, since the majority of that work will now be performed by others, the few remaining proposed early interim actions will be combined with EPA's planned work in 2018. We appreciate the private property owners' interest in performing remedial work on their land and fully support this approach.
- Last month, EPA contractors installed a new valve on the Red and Bonita pipeline. The new valve directs adit flow away from the waste rock pile, which reduces the contaminant load from the mine to Cement Creek.
- As this summer's growing season proceeds, the benefits of last fall's successful revegetation of a field in the BPMD is becoming apparent (see photos below). Pipelines to the

2017 Priorities for Superfund Site Work

Early Actions – initiate interim response actions to address simple water management and waste pile stability concerns.

Stability – identify for future action those mine features that may be the most unstable and at risk of unplanned releases of contamination.

Significant Sources – identify for future action mine features with relatively high contributions of contamination.

Human Health – conduct a Human Health Risk Assessment.

Interim Water Treatment Plan were installed in this area last year. The field had also been heavily utilized during the Gold King Mine response in 2015 and was used for water treatment operations prior to the construction of the Interim Water Treatment Plant.

Planned Activities

- In mid-August, EPA contractors plan to mobilize to the site for the drilling of the horizontal well at the Gold King Mine. When that work is completed, likely in mid-September, installation of the flow control structure in the adit will begin. Following that, the berm outside the historic level 7 adit at the mine will be constructed. This work is intended to reduce the potential of an unplanned discharge from the mine.
- In mid-September, a new pressure gauge will be installed at the Mogul Mine. Prior to that, work will be done on the adit to make the flowrate easier to measure as well as making access to the mine safer.
- During the week of August 21, XRF (X-ray fluorescence) screening will be done on select waste rock piles in the district. XRF is used for non-destructive, real-time chemical analysis of rocks and minerals Also during that week, activity-based air sampling will be conducted.
- Low-flow surface water and sediment sampling will take place the week of Sept. 25, with sampling of seeps and springs taking place later in the fall.
