Community Conversation

We are working with our local and state partners to determine a date for our next community meeting in Butte. Butte Priority Soils Operable Unit (BPSOU) Remedial Design/Remedial Action Progress Meeting (RDRA Progress Meeting)

Onsite Material

As was announced in this week's RD/RA meeting, Atlantic Richfield has decided to remove all onsite materials from the BPSOU corridor project areas that do not meet certain metals criteria in the Consent Decree (CD). Onsite material is soil or other natural material within a Superfund Site that is used to help

cleanup efforts at the Site. EPA supports Atlantic Richfield's decision to remove this material and is appreciative of all the community engagement that has taken place over the last year. EPA looks forward to continuing to progress site work and moving forward in a promising direction.

Office Hours

Office hours with BPSOU remedial project managers (RPMs) Emma Rott and Molly Roby have been taking place since early April at the Butte Silver Bow Readiness Center on Tuesdays from 11:00 am to 2:00 pm. We are very grateful to BSB's Reclamation and Environmental Services staff for hosting. Given the low level of attendance and the need to focus on field work, the team is shifting office hours to once a month. The next office hour dates will be July 16th and August 13th. The team will provide more details about timing and location in upcoming communications. Note that as decisions about lead, repository siting, and others are made, the team will be available for additional office hours to support the community. If there are any recommendations for improving office hours, please reach out to Mackenzie, Charles or Katherine with those suggestions.

Lead (Pb) update

EPA is actively developing a proposed plan to implement the 2024 national lead guidance on the lead cleanup level for the BPSOU. When the proposed plan is released, there will be an opportunity for the public to provide comments. We will keep the Butte community updated as there is more information to share.

Repository Siting

Earlier in May, at a Council of Commissioners meeting, Atlantic Richfield and Butte-Silver Bow presented four candidate sites in Butte-Silver Bow County that could accept wastes from remediation projects set to begin in May 2025. This information was also presented to CTEC on Monday, 6/10. These sites, which were advanced through the siting process after incorporating substantial public feedback, include the Berkeley Pit, an area off Shields Avenue on Montana Resources property, land near the Kelly Mine area, and the existing Butte Mine Waste Repository Site. The process is now in the detailed evaluation phase, and a Draft Detailed Evaluation and Recommendations Report is expected to be completed and shared with the public this fall. Afterwards, the report will be finalized with stakeholder and public input incorporated, and a recommendation will be submitted to EPA, in consultation with DEQ.

Grove Gulch

In late May, after receiving concurrence with DEQ on comments, the agencies were able to issue conditional approval of the 100% Grove Gulch design. Cleanup is set to begin in the coming months pending final design approval. For additional information on Grove Gulch, <u>please visit BPSOU.com</u>.
