Planned Activities

- The Bonita Peak Mining District Site Team will be hosting a series of public meetings tentatively scheduled for the week of April 10, 2017. During the meetings, the team will discuss planned activities at the Superfund site for the 2017 field season.
- Colorado Department of Public Health and Environment is hosting a FREE 8-Hour Health and Safety Refresher and FREE 24-Hour Health and Safety Training on March 27-29, 2017, at Silverton Town Hall, 1360 Greene Street, from 8 a.m. to 5 p.m. The training is required for those working on Superfund sites and will prepare local residents for employment opportunities that may become available in the Bonita Peak Mining District. 2017 Priorities for Superfund Site Work

Early Actions – initiate interim response actions to address simple water management and waste pile stability concerns.

Stability – identify for future action those mine features that may be the most unstable and at risk of unplanned releases of contamination.

Significant Sources – identify for future action mine features with relatively high contributions of contamination.

Human Health – conduct a Human Health Risk Assessment.

- The EPA Office of Research and Development (ORD) is supporting the BPMD Site Team with compilation of vendor information and evaluation of innovative technologies for potential application at the BPMD. Technical support is provided through the ORD Office of Science Policy, Regional Science Program via the Engineering Technical Support Center in Cincinnati. Current activities include:
 - Direct technical support to identify data needs and aid in conceptual site model development;
 - Collection and cataloguing of vendor information and data from existing studies/pilots;
 - Working with the federal and state agencies to identify opportunities for vendors to access media (water, soil, sediment, sludge) for technology testing and refinement; and
 - Conducting literature searches for technology information.

Future activities may include evaluating technologies and providing recommendations for the agencies to consider as part of the remedial investigation/feasibility study (RI/FS) process and working with them to design appropriate pilot studies and data collection to support the FS.
