Site Name: Sharon Steel Fairmont Coke Works Superfund Site

Size: 97 acres total, 50 acres available

Existing Site Infrastructure: 6" Water; 8" Sewer; 4" Gas, 3 Phase Electric, Voice, Data and TV Cable located on site.

Current Site Uses: The West Virginia State Police Troop 1 Headquarters is located on site. About 50 additional acres on site are currently available for redevelopment.

Use Restrictions: Residential uses and potable groundwater use are prohibited. Buildings on part of the site must be constructed with vapor control measures in place.

SETTING:

- The site is 1 ½ miles from 2 exits on I-79 (139 and 137) zoned for public service, highway and commercial use.
- Commercial and residential areas surround the site to the north and east, National Guard Armory to the south (constructed in 2015).
- The Fairmont Coke Works Site Custodial Trust (FCT) owns the site. The state of West Virginia is the Trustee for the FCT.
- Surrounding population: 0.5 mile, 793 people
2.5 miles, 15,936 people | 4 miles, 62,588 people.
- The Big John's Salvage Superfund site is adjacent to the site to the west.

- Site operations resulted in soil, surface water and groundwater contamination.
- EPA added the site to the Superfund program's National Priorities List in 1996.
- Site fully characterized and soil cleanup complete.
- EPA selected the site's final remedy in December 2017. It includes limited groundwater treatment (on 4 acre parcel), monitoring, wetlands restoration, and institutional controls to limit site uses and restrict groundwater use.
- Implementation of the site's long-term remedy is ongoing.

REMEDIAL STATUS:

- Coke production, waste treatment and waste disposal operations took place on site prior to 1973.
