Site Name: Redwing Carriers, Inc. (Saraland) Superfund Site

Size: 5.1 acres

Existing Site Infrastructure: Water, sewer, natural gas and electricity are available on site.

Readiness for Reuse: The site is ready for unlimited use and is zoned residential.

Use Restrictions: The site does not require any institutional controls because it was cleaned up to residential standards to allow for unlimited use and unrestricted exposure.

SETTING:

- The site is zoned for residential use.
- The site is surrounded by residential and commercial use.
- Surrounding population: 0.5 mile, 1,212 people | 2.5 miles, 11,262 people | 4 miles, 24,616 people.

REMEDIAL STATUS:

- From 1961 to 1971, Redwing Carriers, Inc., a trucking company, owned and operated a terminal for cleaning and repairing trucks on the site. The company also parked its fleet of trucks on the site. The company transported a variety of substances, including asphalt, diesel fuel, chemicals, and pesticides from local plants. Activities contaminated the site.
- In 1973, Saraland Apartments purchased the site property and built an apartment complex. Due to the complex's construction on contaminated soil, tar-like sludge seeped into the complex in numerous locations.

- The site was placed on the National Priorities List (NPL) in February 1990. The apartment complex was demolished in 2004. Cleanup included excavation and off-site disposal of contaminated soil. Groundwater monitoring has shown that contamination has not migrated off site. EPA took the site off the NPL in 2015.
- Cleanup is complete. The site was cleaned up to residential standards, allowing for unlimited use and unrestricted exposure. The site no longer poses a risk to human health or the environment.
