# Schedule under Order

This letter confirms the schedule for the remaining Remedial Investigation/Feasibility Study (RI/FS) tasks under the 1987 Administrative Order for the Old Southington Landfill Site (EPA Docket No. I-87-1112). As we discussed on February 27, 1991, the following is the new schedule under the Order and is a partial modification to the schedule previously approved by EPA in my letter of October 30, 1991:

March 22, 1991

One to two page proposal on level 4 soil gas sampling (as an alternative to ambient air sampling) and dispersion model.

Revised Site Characterization and Baseline Risk Assessment Reports.

Meeting between EPA and PRPs to discuss need, if any, and scope for Post Screening Investigations Work Plan.

### Draft Remedial Investigation.

By July 1, 1991, if not before, EPA will discuss the progress of the RI/FS with the PRPs and issue a revised schedule under the Order for submission of the RI, the draft FS, and the final RI/FS. The due date for the Detailed Analysis of Alternatives Work Plan will be set in a letter to you after the April 5 revisions are submitted.

Please send EPA twelve copies of the Revised Site Characterization Report and six copies of the Revised Baseline Risk Assessment Report by April 5. This would greatly facilitate and expedite our review process to assure that we all meet our new schedule.

## Other Issues

As we discussed on February 27, the PRPs must carry out additional air testing and that information must ultimately be included in the final RI and risk assessment. The fact that EPA and the PRPs are discussing how to carry out and report this information should be noted in the revised Site Characterization Report and Baseline Risk Assessment that is submitted April 5, but the write-up on specifics of how that will be done, the data, and the analysis need not be included in the April 5 revisions.

GZA should include in the Draft RI the results obtained from the methane trench pilot study conducted at the site; this need not be included in the April 5 revisions.

As requested by GZA at the meeting, EPA is currently reviewing the Executive Summary and Conclusions sections of Volume IA to determine if EPA has additional comments beyond those already conveyed to the PRPs.

On the issue of the sampling procedure of well points for the risk assessment, EPA has reviewed the Sampling and Analysis Plan, Attachment B, prepared by GZA dated December 1987 and revised May 1988. This report states on page 17, first paragraph, that sample points located on or immediately adjacent to the landfill will be collected as filtered and non-filtered. Sample points taken from other areas will be filtered. Thus the procedure that GZA followed is correct.

Finally, the PRPs should furnish the Menards with the data taken from their well.
