Re: Solvents Recovery Services Site of New England; Monsanto Response to Second § 104(e) Request

Dear Ms. Goldberg:

This responds to a second request for information from the U.S. Environmental Protection Agency, Region I ("EPA" or "the Agency") directed to Monsanto Company, dated December 7 and received December 11, 1992, concerning the Solvents Recovery Services Site of New England ("SRSNE") (copy enclosed).

Monsanto has previously responded to EPA mailings concerning the SRSNE site, by correspondence dated November 16, and December 9, 1992. We hereby continue all objections and defenses stated in those earlier communications without waiver.

EPA's second § 104(e) package contains two "Form 1" sets/requests, one referring to "Monsanto Co." and the other to "Monsanto Chemical (Indian Orchard)." EPA's earlier transactional audit package provided backup documents for the transactions noted on these two Form 1's. We can confirm that EPA's contractor correctly converted drums to gallons for the two "Monsanto Co." transactions listed and the six "Monsanto Chemical (Indian Orchard)" entries. We can further state that some of the backup documents for the "Monsanto Chemical (Indian Orchard)" plant entries appear to have notations concerning the nature of the materials involved.

Because the date of the transactions listed on the Form 1's exceed Monsanto's document retention period, we have no independent information to confirm or deny the amounts listed in the documents or on the Form 1's enclosed with both § 104(e) Requests. Nor do we have information concerning the waste types, transporters, or site-selectors for these materials.

EPA's second information request also directs Monsanto to provide information concerning transactions with SRSNE not listed on either set of Form 1's. In responding to the Agency's previous information request, Monsanto located additional information not contained in EPA's first § 104(e) information request and/or transactional audit packages, and provided that information to the Agency. See December 9, correspondence package. Since the date of that December 9, communication, Monsanto has not located any further information or documents pertaining to the SRSNE site. Our efforts to locate such information continue, and in the event further relevant information is located, it will be provided to EPA.

As stated in that December 9, communication, however, we can inform the Agency that the facilities it has listed as "Monsanto Chemical (Indian Orchard)," "Monsanto Chemical (Springfield, MA)," and "Monsanto Chemical (Worcester)," as well as the new information for Monsanto Bircham Bend, are all the same plant facility -- Monsanto's Indian Orchard plant (formerly the Springfield and Bircham Bend plants) on Worcester Street in Springfield, Massachusetts. The Agency may be able to simplify its recordkeeping with this information.

We trust this adequately responds to EPA's information request. Again, please correct your mailing list, and direct any questions or further correspondence concerning this Site to the undersigned.

Re: Request for Information for Solvents Recovery Service of New England (SRSNE) Superfund Site in Southington, Connecticut

Dear Ms. Whitby:

The United States Environmental Protection Agency (EPA) is requesting information regarding the nature of waste shipped to the Solvents Recovery Service of New England (SRSNE) Superfund Site in Southington, Connecticut (hereinafter referred to as "SRSNE" or "the Site") from 1955 through 1980.

Pursuant to the authority of Section 104(e) of the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA), 42 U.S.C. § 9604(e), and Section 3007 of the Resource Conservation and Recovery Act (RCRA), 42 U.S.C. § 6927, you are hereby required to respond to the Information Request set forth in the Enclosures accompanying this letter.

This inquiry is distinct from the optional transactional document review package previously sent to you. Enclosure A contains general instructions and definitions to assist you in preparing your response. Enclosure B provides the Information Request Forms you must complete in order to comply with this request. EPA has developed the forms with the intent of facilitating your response and expediting EPA's review of your response. EPA will not accept responses that are not provided to EPA on the enclosed forms. Your response must be postmarked within twenty (20) calendar days of receipt of this letter.

Compliance with the Information Request set forth in the Enclosures is mandatory. Failure to respond fully and truthfully to the Information Request within twenty (20) days of receipt of this letter (which includes providing ambiguous, evasive, or incomplete answers), or to adequately justify such failure to respond, can result in enforcement actions by EPA pursuant to Section 104(e) of CERCLA, and/or Section 3008 of RCRA. Each of these statutes permits EPA to seek the imposition of penalties of up to twenty-five thousand dollars (\$25,000) for each day of continued non-compliance. Please be further advised that provision of false, fictitious, or fraudulent statements or representations may subject you to criminal penalties under 18 U.S.C. § 1001 or Section 3008(d) of RCRA.

This Information Request is not subject to the approval requirements of the Paperwork Reduction Act of 1980, 44 U.S.C. § 3501 et seq.

If the response fails to address the period being investigated, EPA will consider this a failure to comply with the request and may take action against you for this noncompliance.

If, at any time after the submission of this response, you discover or believe that any portion of the submitted information is false or misrepresents the truth, you must notify EPA of this fact as soon as possible and provide EPA with a corrected response. If any part of the response to this Information Request is found to be untrue, the signatory to the response and the company may be subject to criminal prosecution.

INFORMATION REQUEST DEFINITIONS

All terms not defined herein shall have their ordinary meaning, unless such terms are defined in CERCLA, 42 U.S.C. Section 9601 et seg., RCRA, 42 U.S.C. Section 6901 et seg., Volume 40 of the Code of Federal Regulations (CFR), or other applicable statute or regulation, in which case such statutory or regulatory definitions shall apply.

The following definitions shall apply to the following words as they appear in this Enclosure B:

- 1. The term "you" or "Respondent" shall mean the addressee of this Request, the addressee's officers, managers, employees, contractors, trustees, successors, assigns, and agents, and any predecessor or successor corporations, companies, or operations of the addressee.
- 2. The term "arrangement" shall mean any agreement between two or more persons.
- 3. The term "broker" shall mean the person that is listed as the "customer" on SRSNE records with respect to a transaction involving waste material that was generated by another company.
- 4. The terms "document" and "documents" shall mean any method of recording, storing, or transmitting information. "Document" shall include but not be limited to:
 - (a) writings of any kind, formal or informal, whether or not wholly or partially in handwriting, including (by way of illustration and not by way of limitation), any of the following:
 - invoice, receipt, endorsement, check, bank draft, cancelled check, deposit slip, withdrawal slip, order:
 - letter, correspondence, fax, telegram, telex;
 - 3. minutes, memoranda of meetings and telephone and other conversations, telephone messages;
 - 4. agreement, contract, and the like;
 - 5. diary, calendar, desk pad, journal;
 - 6. bulletin, circular, form, pamphlet, statement;
 - 7. report, notice, analysis, notebook;
 - 8. graph or chart; or
 - copy of any document.

- (b) microfilm or other <u>film record</u>, any <u>photograph</u>, <u>sound</u> recording on any type of device;
- (c) any tape or other type of memory generally associated with <u>computers</u> and <u>data processing</u> together with:
 - the programming instructions and other written material such as punch card, disc or disc pack, tape or other type of memory; and
 - printouts such as punch card, disc or disc pack, tape or other type of memory; and
 - (d) drafts and other backup documents such as
 - every copy of each document which is not an exact duplicate of a document which is produced, including every copy which has any writing, figure or notation, annotation or the like on it;

The term "identify" means, with respect to a natural person, to set forth: (a) the person's full name, (b) present or last known business address and business telephone number (or if this is not available, last known home address and home telephone number), and (c) present or last known employer (include full name and address) with job title, position or business.
- 6. The term "identify" means, with respect to a corporation, partnership, business trust or other association or business entity (including a sole proprietorship), to set forth: (a) its full name, (b) complete street address, (c) legal form (e.g., corporation, partnership, etc.), (d) the state under whose laws the entity was organized, and (e) a brief description of its business.
- 7. The term "identify" means, with respect to a document, to provide its customary business description (e.g., letter, invoice), its date, its number if any (e.g., invoice or purchase order number), the identity of the author, addressor, addressee and/or recipient, and the substance or the subject matter.

- 8. The term "materials" shall mean any and all objects, goods, substances, or matter of any kind. "Materials" shall include but not be limited to wastes, non-hazardous materials, hazardous substances, pollutants or contaminants, and hazardous wastes.
- 9. The term "person" as used herein includes, in the plural as well as singular, any natural person, firm, unincorporated association, partnership, corporation, trust or other entity.
- 10. The term "site" shall mean the SRSNE facility in Southington, Connecticut.
- 11. The term "transporter" shall mean the person engaged in the transportation of waste material by air, rail, highway, or water.
- 12. The term "waste" or "wastes" shall mean and include trash, garbage, refuse, solvents, liquid wastes, solid waste, sludge, containers for temporary or permanent holding of wastes, by-products, waste oils, materials to be recycled or treated, hazardous waste, hazardous substances, pollutants or contaminants.
