## Introduction to the Collection

This is the Administrative Record Index for the New Bedford Harbor Superfund Site, New Bedford, MA, Operable Unit 1, Lower Harbor Confined Aquatic Disposal (CAD) Cell Explanation of Significant Differences (2011 CAD Cell ESD), released March 2011. This Administrative Record modifies the 1998 Upper and Lower Harbor Record of Decision (1998 ROD) for the New Bedford Harbor Superfund Site issued September 25, 1998, and three subsequent ESDs that modified the remedy established under the 1998 ROD, and contains site-specific documents and references the guidance document used by EPA in modifying the response action at the site.

This record replaces the Draft Explanation of Significant Differences (2010 Draft CAD Cell ESD) for Public Comment, released June 2010. This Record incorporates by reference, the Administrative Record files for the 1998 ROD, including the Administrative Records for the 2001 Upper and Lower Harbor ESD, the 2002 Upper and Lower Harbor ESD and the March 2010 Upper and Lower Harbor ESD, as well as the Administrative Record for the Administrative Order for Property Access established January 9, 2001 for the New Bedford Harbor Superfund Site. This Record also incorporates by reference the Administrative Record for the 1990 Hot Spot ROD, including the Administrative Records for the 1992 Hot Spot ESD, the 1995 Hot Spot ESD, the Administrative Record for the Access Order for the New Bedford Harbor Superfund Site established September 10, 1993 and the Administrative Record for the Amended Hot Spot Record of Decision established on April 27, 1999.
