

Ok, now I know who you meant, Bryan Olson. Bryan is the Director of the Superfund Program (Office of Site Remediation and Restoration); <u>olson.bryan@epa.gov</u> and 617-918-1201.

I really am barred from responding to individual questions which are submitted during the public comment period. But let me see what I can do. We may have researched this technology already. If so, I may be able to get something to you quickly. If not, it will take time to research anyway.

My general response in cases like this is that even if Amiante Ovens can effectively treat the concentrations of asbestos were have measured in soil in Stratford, it likely would not touch the other toxic chemicals which are co-located in this buried waste, or worse yet, heating the soil to treat the asbestos could form toxic vapors from the other chemicals (e.g., PCBs or dioxins). That is generally the problem we face in the Superfund program is that a treatment process works great for 1 chemical, or even a group of chemicals, but doesn't touch all the other chemicals, or even makes the other chemicals worse in some way. It's the mixed nature of these chemicals which is the real problem when it comes to treatment. These technologies all look at treating a single chemical or chemical group. The mixture of chemicals in Raymark Waste is unique, as is the mixed mess of chemicals at any individual Superfund site. But, I do try to keep an open mind!

I will try to get back to you later today.


