

## **Parties That Received the March 31, 2016 Notice of Potential Responsibility for the Lower 8.3 Miles of the Lower Passaic River, Operable Unit Two of the Diamond Alkali Site**

Below is the list of parties to which EPA sent the March 31, 2016 notice of potential responsibility for the Lower 8.3 Miles of the Lower Passaic River, Operable Unit 2, of the Diamond Alkali Superfund Site. Due to mergers, name changes and other corporate transactions, the name of the original company that owned or operated a facility adjacent or near to the Lower Passaic River may have been different than the name that appear below. The list of potentially responsible parties could change over time as new information becomes available.

It should be noted that a notice of potential liability is not a legal determination, but it does provide notice of EPA's understanding of the recipient's status, based on information known to EPA. EPA may revise a party's status as additional information is received. A notice letter is also intended to provide a party with an opportunity to participate in the Superfund process.
