

# EPA PUBLIC NOTICE

## U.S. Environmental Protection Agency Reviews Cleanup of the Lawrence Aviation Industries Superfund Site

The U.S. Environmental Protection Agency (EPA) is conducting its second five-year review of the **Lawrence Aviation Industries (LAI) Superfund Site**, located in Port Jefferson Station, Suffolk County, New York. This review seeks to confirm the remedy selected by EPA in a September 2006 Record of Decision is protective of human health. The selected remedy included the following components:

- Excavation of contaminated surface soil on the LAI facility;
- Installation of groundwater extraction and treatment systems both at the LAI facility and within the plume area near Old Mill Pond to address contaminated groundwater;
- *In-situ* (in place) chemical oxidation (ISCO) applied as an enhancement within the area of high concentrations of contamination in groundwater at the LAI facility;
- Long-term groundwater monitoring; and,
- Implementation of institutional controls.

A summary of the five-year review activities and an evaluation of the protectiveness of the remedy will be included in the upcoming five-year review report. It is anticipated that the five-year review report will be completed by February 2020.

### What is an EPA Five-Year Review?

EPA inspects Superfund sites every five years to ensure that cleanups conducted remain fully protective of human health and the environment. These regular reviews, which are required by federal law when contaminants remain at a site, include:

- Inspection of the site and cleanup technologies;
- Review of monitoring data, operating data, and maintenance records; and,
- Determination if any new regulatory requirements have been established since EPA's original cleanup decision was finalized.
