RESPONSE ACTIVITIES

Site Summary

The facility was originally a U.S. Army Ordnance works during World War II. Presently the site is used as a wildlife refuge and is owned and operated by the State of West Virginia. It is suspected that portions of the site contain buried ordnance. Process lines associated with the manufacturing of TNT are still underground and possibly partially filled with crystalline TNT. Surface water (Pond 13) has shown contamination of DNT (Dinitrotoulene) a chemical precursor of TNT. This is still the State priority site.

Past

April 1981

Preliminary investigation by WV DNR. Recommends survey of site by technical expertise.

April 30, 1981

Preliminary Assessment by WV DNR. Apparent seriousness of problem - high.

June 4, 1981

Site Inspection by WV DNR. Apparent seriousness of problem - high. Samples taken.

June 29, 1981

Preliminary Assessment by EPA/FIT. Apparent seriousness of problem - low. Recommends limited immediate measures.

October 5, 1981

Scope of Work and Action Memorandum sent to Headquarters by Region.

October 6, 1981

Field Investigation by EPA/FIT, WV DNR. Samples taken.

November 2, 1981

Sample results show high levels of DNT in Pond #13.

December 30, 1981

EPA/EEB submits documentation for emergency actions at McClintic.
Headquarters denies the request.

February 5, 1982

EEB/EPA Region III requests monies under CERCLA 104(B) to study McClintic.
Headquarters denies this request.

May, 1982

TAT study, using special funds is performed at McClintic.

June 14, 1982

Wells are drilled as part of the special TAT study.

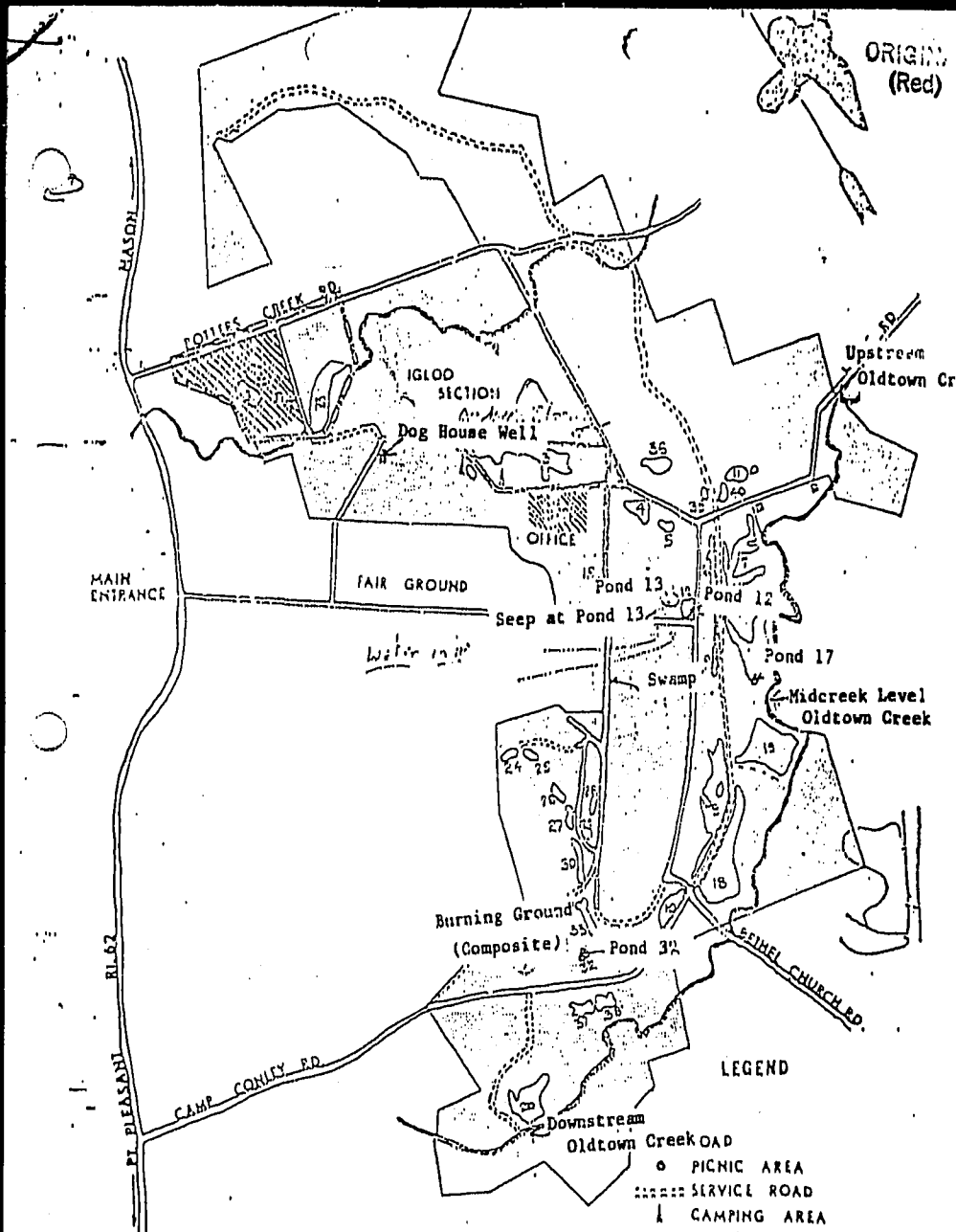
Present

At this time WV DNR has sampled the groundwater and will receive the results shortly. TAT's report is due soon.

Future

McClintic is still the State's "Top Priority Site" and has been submitted for inclusion on the "National Priorities List". Remedial Investigation/Feasibility Study would be initial step in any further actions at the site.
