This letter is in response to the Request for Information Pursuant to Section 104(e) of the Comprehensive Environmental Response, Compensation and Liability Act of 1980, 42 U.S.C. §9604(e), amended by the Superfund Amendments and Reauthorization Act of 1986, PL 99-499 ("CERCLA") and Section 3007 of Resource Conservation and Recovery Act, 42 U.S.C §3007 ("RCRA") dated August 2, 1989 to M. A. Hanna Company in connection with Electric Hose and Rubber Company. Hanna is responding to this request as successor in interest to certain obligations of Electric Hose and Rubber Company.

As a preliminary matter, Hanna objects to this Request on the grounds, among others, that the (a) Environmental Protection Agency has not established that Section 3007 of RCRA applies to Hanna under the circumstances of this matter; and (b) the instructions, definitions and questions of such Request are overly broad, unduly burdensome and exceed the authority of Section 104 (e) of CERCLA

Without waiving or in any way limiting any objection it has or may have to this Request, Hanna provides the information set forth below and attached hereto. The search for information has proved to be difficult because of Hanna's position as a successor in interest to certain liabilities of Electric Hose and Rubber Company. Hanna acquired Day International Corporation, (formerly Dayco Corporation) in 1987. Day International Order acquired Electric Hose and Rubber Company in 1978 and shortly thereafter

closed the Electric Hose and Rubber's Wilmington, Delaware facility and moved it to Ocala, Florida. In 1986, Day sold Electric Hose and Rubber to Armstrong Rubber.

In preparation of this response, Hanna relied upon interviews conducted with past employees (see list set forth as answer to question 14) and intends to attempt to locate files, if any are obtainable, regarding this Request. Hanna will supplement this response with additional relevant information should it be uncovered or otherwise be made available. The answers set forth below correspond to the numbered questions in the Request.

- Cardboard, paper, fabric rayon and very small amounts of scrap rubber. No quantities are known.
- Solid wastes as described in #1, above, were generated. No information is available on the storage of these wastes.
