With reference to your letter of August 15th and our telephone conversation of today, please be advised that the Cronite Company has not heard of nor had any dealings with Eastern Diversified Metals Corporation or Diversified Industries Inc. or Theodore Sall, Inc.

We are suppliers to the engraved stationery industry which is a relatively small group in the United States and I am personally aware of everyone of our customers including the times that you mentioned from 1966 to 1977 and none of these names are familiar with us.

As I mentioned, I was personally aware that another Cronite Company existed and a search of our records shows that in September of 1978 I became aware that a North American Cronite Inc. at 13800 Progress Parkway, North Royalton, Ohio 44133 was in existence as a division of Cronite Group Ltd. A record of this was kept in our files because of a possible trademark infringement. I believe that this company is now located in Cleveland, Ohio.

Dear Mr. Beloti:

The Environmental Protection Agency (EPA) is seeking information concerning a release, or the threat of a release, of hazardous substances into the environment. Pursuant to the authority of Section 3007(a) of the Resource Conservation and Recovery Act (RCRA), 42 U.S.C. \$6927(a), and Section 104(e) of CERCLA, 42 U.S.C. \$9604(e), you are requested to furnish all information and documents in your possession, which concern, refer, or relate to, but not limited to, hazardous wastes and/or substances as defined by Section 101(14) of CERCLA, 42 U.S.C. \$ 9601(14), and any type of substances or materials which were transported to, stored, or disposed of at the Eastern Diversified Metals Site located approximately 1000 (one-thousand) feet off the Lincoln Avenue in Hometown, Schuylkill County, Pennsylvania.

The response should include, but not be limited to, information and documentation concerning:

- 1. The types and quantities of the substances sent to the Eastern Diversified Metals Site;
- 2. The date(s) such substances were sent to the Eastern Diversified Metals Site;
- 3. The state (i.e., liquid, solid, or gaseous) of the substances sent to the Eastern Diversified Metals Site, and the manner in which the substances were treated, stored or disposed (i.e., drummed or uncontained, placed in lagoons, landfilled, placed in piles, etc.);
- 4. Any correspondence between your corporation and any regulatory agencies regarding such substances;
