On July 27 2005 the WITNESS was interviewed at his residence by

Senior Investigator of The WITNESS was interviewed as part of the Potentially Responsible party scaled on ently being conducted under Task 0001, Site 7 involving the Sauer Dump Dundalk, MD (the Site) The WITNESS was provided with a copy of the letter of introduction, advised of the nature of the questions to be asked, and that the interview was voluntary. The WITNESS stated that he is not represented by an attorney in this matter and does not want an attorney. No other persons were present during this interview and the interview was not tape-recorded.

During the course of this interview the WITNFSS responded to questions based on guidelines provided by the United States Environmental Protection Agency for area residents

The WITNESS was shown an aerial photograph of the Site. This aerial photograph was used as a reference throughout the interview. The aerial photograph used during this interview will be forwarded under separate cover.

The WITNESS was asked to explain his association with the Sauer Dump located adjacent to Lynhurst Road in Dundalk MD

The WITNESS stated that he was raised at his current address and has lived there since 19 The WITNESS stated that he was willed the property when his parents died

The WITNESS was asked if he was familiar with the Site. The WITNESS stated 'yes. The WITNESS stated that he was friendly with Fritz Sauer and visited the Site occasionally.

When asked if Fritz Sauer disposed of waste at the Site the WITNESS stated 'yes. The WITNESS stated that Fritz Sauer operated a waste hauling business from the late 1960s to approximately the mid-1980s. The WITNESS stated that Sauer disposed of this waste at the Site.

When asked the names of the waste generators from which Fritz Sauer hauled waste to the Site the WITNESS stated that he could only recall the name of two companies and provided the following



National Br. wing Company The WITNESS stated that he observed numerous bottles and cans from this brewery dumped at the Site. The WITNESS stated that Fritz Sauer gave any undamaged cans of beer to many of the neighbors on Lynhurst Road.

O Brian Paint company The WITNESS stated that he had observed numerous cans and buckets with the name 'O Brian Paint Company The WITNESS stated that many of the buckets and cans contained liquids

The WITNESS stated that he also observed numerous 55-gallon drums containing creosote. The WITNESS stated that the drums of creosote had been brought to the Site in waste from one of Fritz Sauer's customers. The WITNESS could not recall the name of this customer.

The WITNESS stated that most of the homes on the west side of Lynhurst Road back up to the Back River. The WITNESS stated that most of the homeowners living in these homes built boat docks behind their houses. The WITNESS stated that Fritz Sauer offered creosote to many of the residents on Lynhurst Road sometime in the mid-1970s. The WITNESS stated that most of the residents who had boat docks used this creosote to paint the piling used to build the boat docks. When asked the names of any residents that took creosote from the Site and the inline for heat ramps, the WITNESS stated that he observed treating the piling for his boat dock with this creosote.

When asked to identify the location of the creosote drums on the Site the WITNESS stated that some of the drums were located close to the office. The WITNESS stated that he had also observed drums on the ground near fill areas on the Site.

The WITNESS stated that much of the waste that Fritz Sauer dumped at the site was buried and he seldom had an opportunity to observe the names on any items brought to the Site

When asked the names of individuals that may have knowledge of wasta disposal activities at the Site the WITNESS provided the following

The WITNESS stated that was a close friend of Fritz. Sauer and was seen at the Site on numerous occasions
