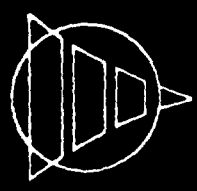

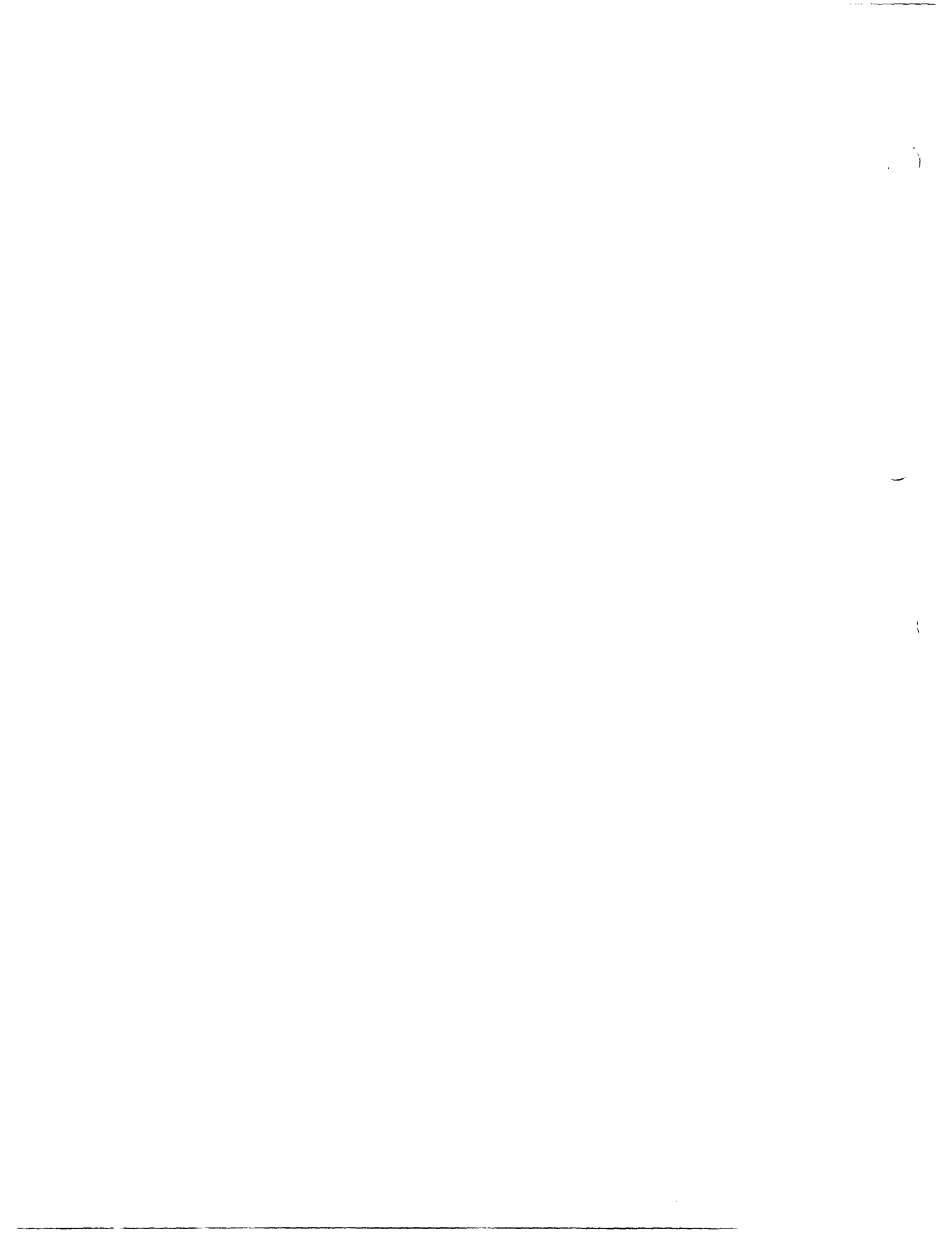

1.0 INTRODUCTION

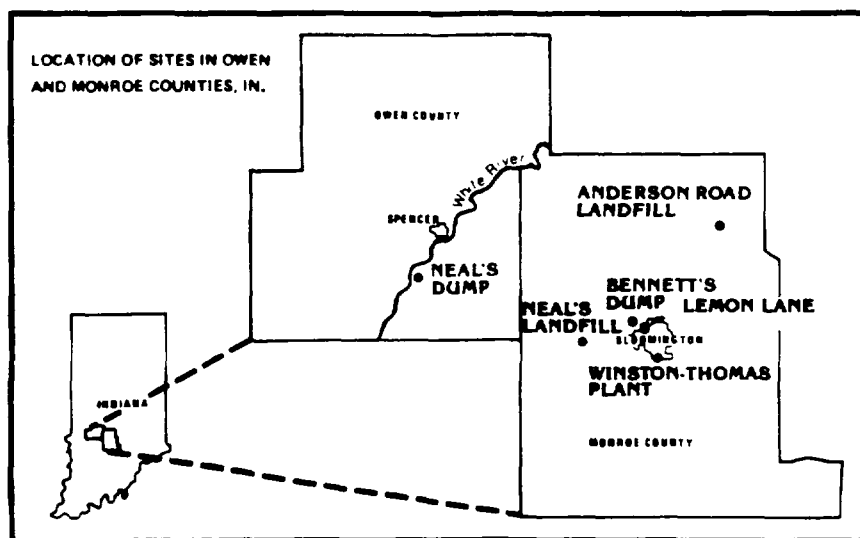


Figure 1. Location map of PCB-contaminated sites included in the Consent Decree.

A negotiated settlement (hereafter the Consent Decree) between the Federal Government, the State of Indiana, the City of Bloomington, Monroe County and the Westinghouse Electric Corporation provides procedures by which polychlorinated biphenyls (PCBs) and PCB-contaminated materials will be removed from six sites in and around Bloomington, Indiana (Figure 1). The contaminated materials ultimately will be destroyed by incineration.

An initial work element, described in Paragraph 72 of the Consent Decree, requires that a survey be conducted "to identify the location (street address and owner) of private wells currently used for commercial or residential purposes within a 5,000-foot radius from the boundary of each of the following sites: Neal's Landfill, Lemon Lane Landfill, the Winston-Thomas Facility and Bennett's Dump." This report presents the results of this well water user survey. Following the survey, the City of Bloomington will contact the well owners to arrange for testing the water from each well.

2.0 METHODS

2.1 Study Area Delineation

Metes and bounds maps for Lemon Lane Landfill, the Winston-Thomas Facility and Bennett's Dump were xerographically reduced to a 1" = 1000' scale and sited on a City of Bloomington Engineering Department map of that scale, using site location maps prepared by Blasland and Bouck Engineers. The metes and bounds map for Neals Landfill was xerographically reduced to a 1" = 2000' scale and sited on a 7.5 min USGS topographic map (Whitehall Quad). The 5,000 foot radii from the boundaries of each site were then drawn in (Figures 2-5).

2.2 Property Identification

Once the study area boundaries were delineated on paper, our project staff field-checked the intersections of the boundaries with all streets and roads to determine the outer limits of addresses that were included in the study areas. When in doubt of the exact location of the boundary line in the field, extra properties were included to insure that at least a 5,000 foot radius was included in the study areas. There is no single listing of addresses that completely covers all properties within the study areas. Therefore, a number of sources were used to identify the properties, their owners and their telephone numbers.

Polk Directory

The Polk's City Directory (Polk 1985) contains a street directory of householders and businesses in Bloomington. We used this directory to get an initial list of properties and owners for each area. However, because the preparation of the Polk Directory depends on owner response to questionnaires, many properties had no information other than the street address. In addition, areas outside the corporate boundaries of

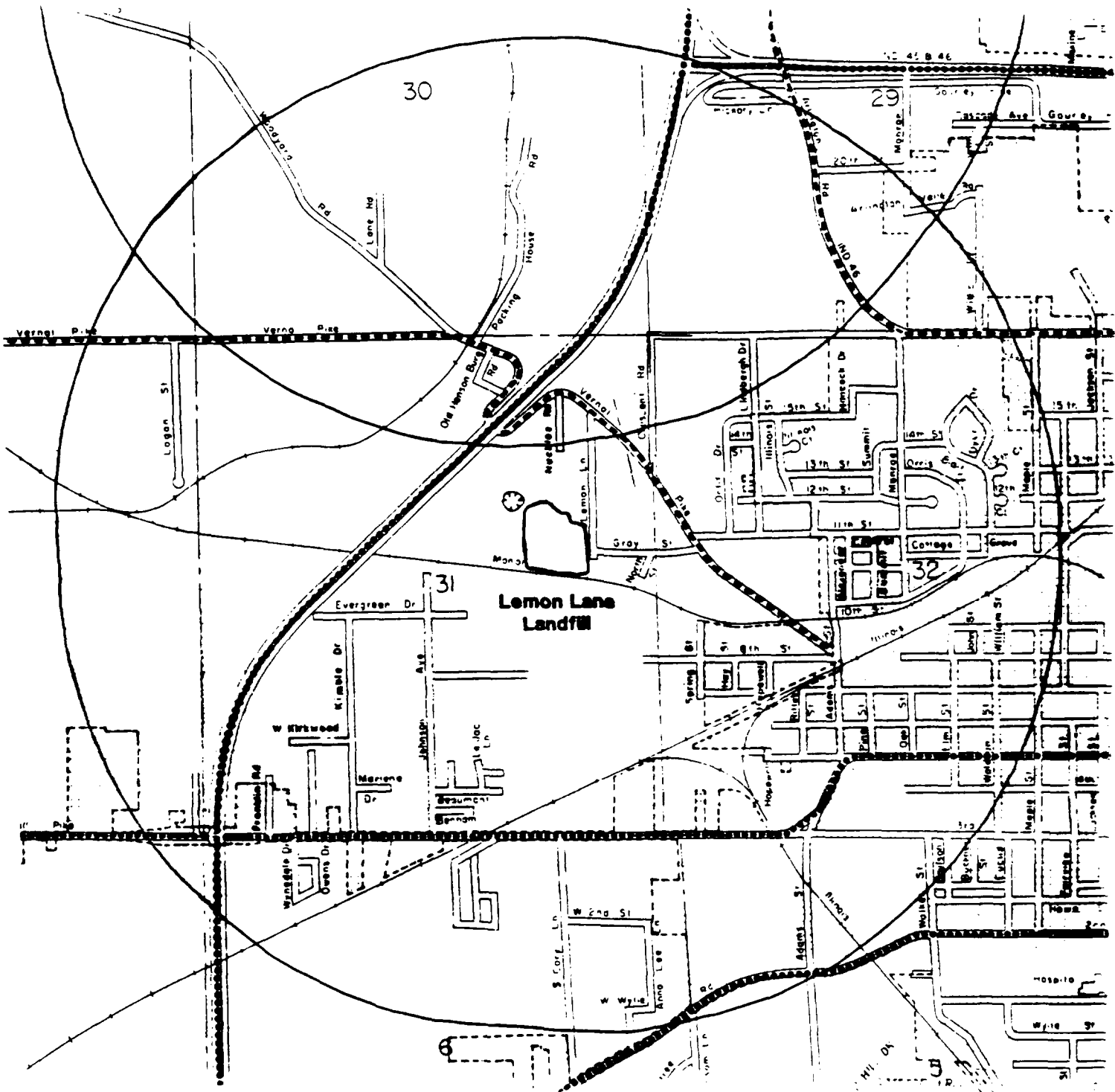


Figure 3. Map of Lemon Lane Landfill study area (5,000 foot boundary is indicated). Overlap at top is with Bennett's Dump.

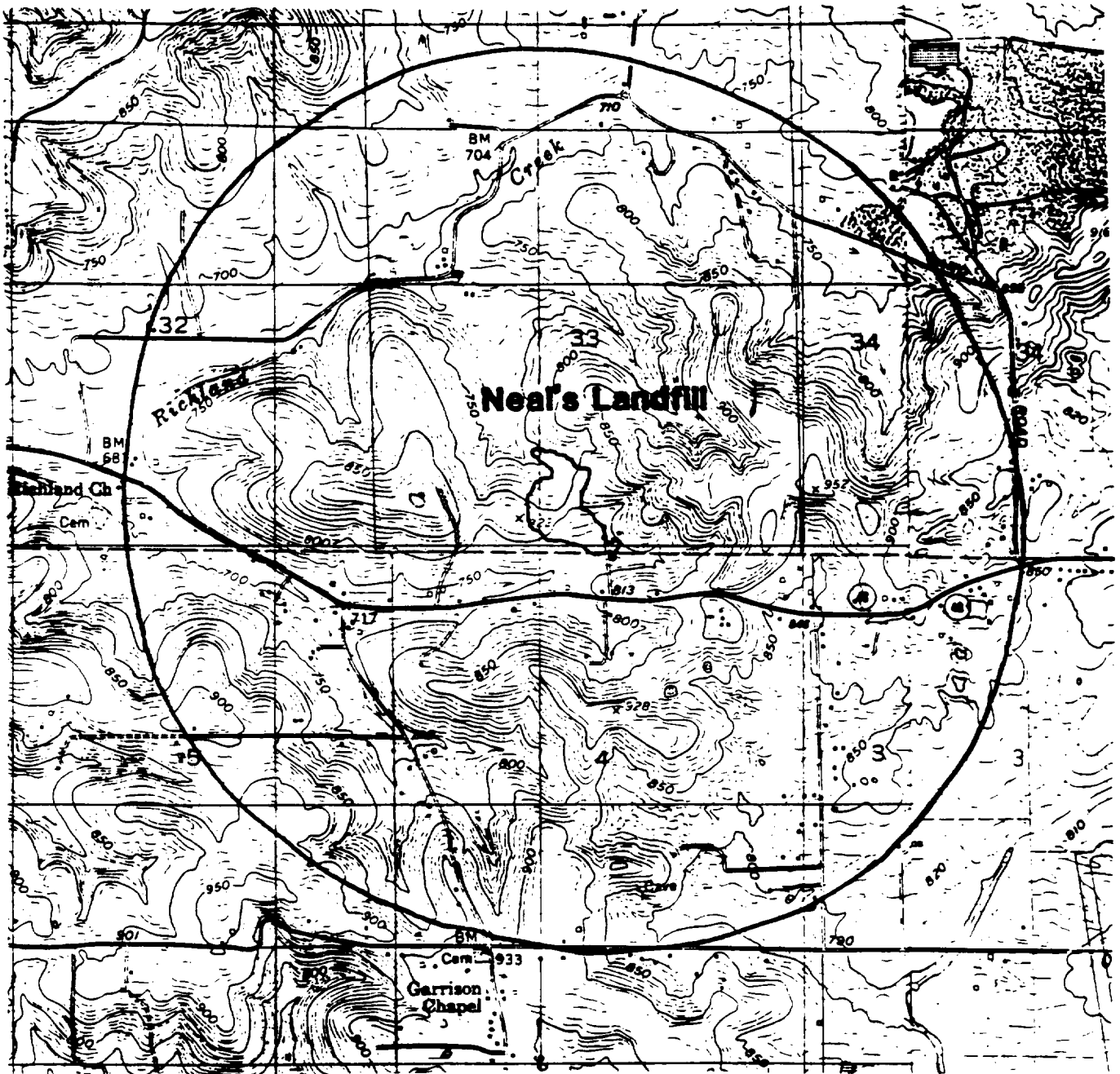


Figure 5. Map of Neal's Landfill study area (5,000 foot boundary is indicated).

Bloomington were generally not included in the directory. Finally, due to moves after the directory was published, omissions and other inaccuracies, many listings in the Polk Directory were incorrect.

Utilities Department

The City of Bloomington Utilities Department has listings of all Water Department customers organized by street address. These records were helpful in filling in gaps in the Polk Directory, however; no telephone numbers are included and not all properties within the study areas receive water from the Bloomington Utilities Department.

County Records

Records kept at the Monroe County Recorder's and Assessor's Offices were used to identify owners of properties not listed in other sources. This was particularly needed in the Neal's Landfill study area which is outside the Bloomington city limits and is not included in the Polk Directory or served by Bloomington city water. A large number of properties in the other study areas had to be searched for in the Recorder's and Assessor's offices as well. However, searching through these records is quite slow and time consuming. Plat maps in the Recorder's Office show property boundaries but few roads or landmarks to get bearings with. Property owners are listed for each property but the addresses in the transfer books were occasionally not up to date. For example, one property owner listed in the records told us he had sold the land more than five years ago. When this was the case, we accessed the computer file in the Treasurer's Office which lists the addresses where tax statements are mailed. Again, we discovered that some of these addresses were not current when our letters were returned by the post office stamped "no such address", "no forwarding address", "unknown" or similar designation.

Possible reasons for the county records not containing the current addresses of property owners include:

1. Cases where the property was recently transferred.
2. Contract sales where the original owner has moved.
3. Cases where the taxes are paid by a mortgage company.
4. Cases where an absentee owner has moved without notifying the Recorder's or Treasurer's offices.
5. Cases where the property owner routinely pays taxes in person and has never updated the mailing address from the old rural route system.

Field Verification

To verify our property lists, our staff drove along every street and road in the study areas, comparing each house number with our lists. Many additional properties were added in this way. We could not field verify the address of properties that had no dwelling or mail box.

2.3 Determining Telephone Numbers

A large number of properties in the Polk Directory had current telephone numbers. A few of the remaining properties had current listings in the telephone directory but the majority of these remaining properties required Directory Assistance calls to get current numbers. In addition, a surprisingly large number of properties (5-10%) either had no telephone or had unlisted numbers.

2.4 Survey Protocol

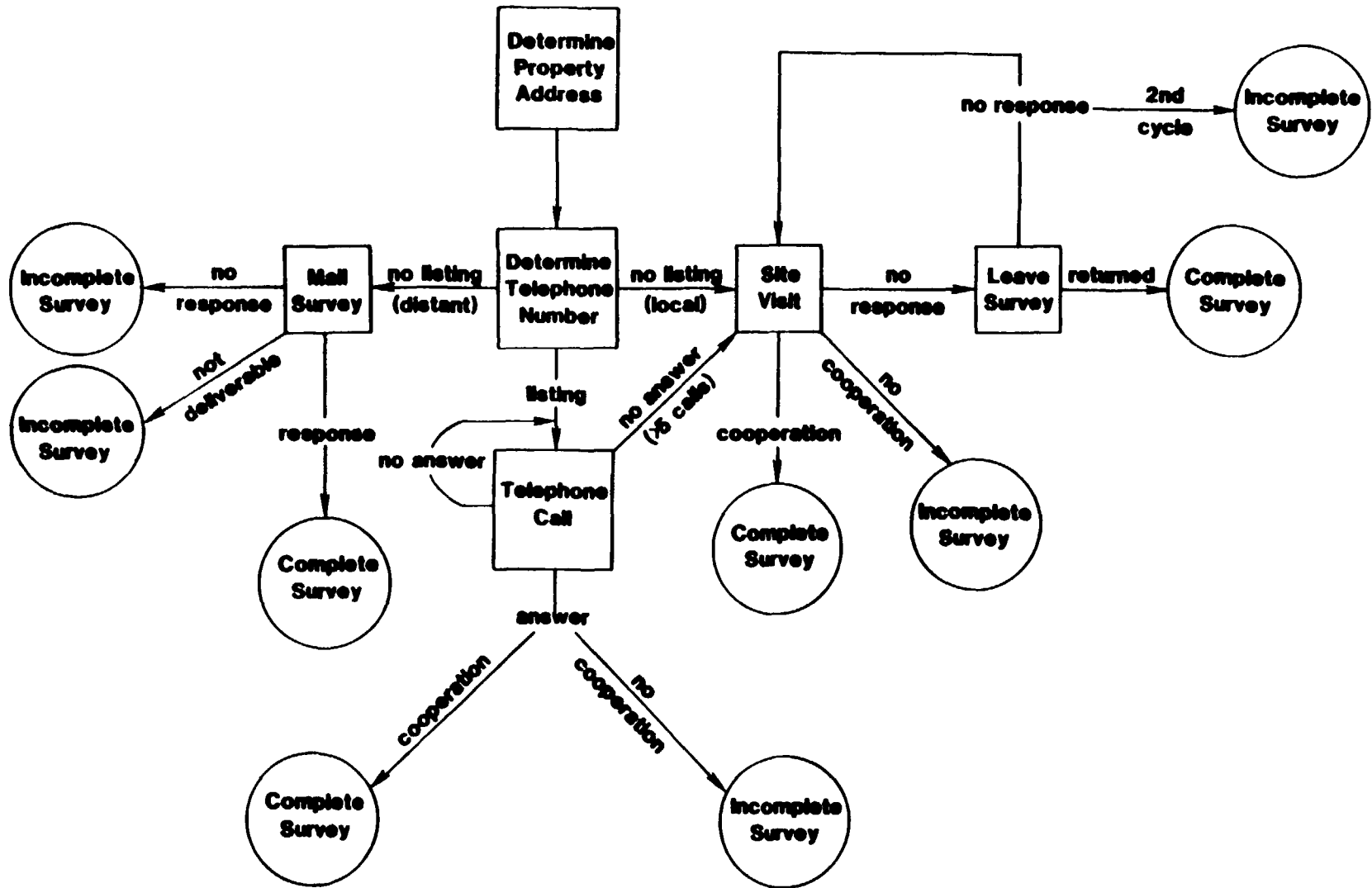


Figure 6. Flow diagram of survey protocol.

The primary mechanism used to collect information regarding wells was a telephone survey. The protocol was standardized and included a brief introduction followed by a short questionnaire (Appendix A). In some cases, survey questionnaires were also mailed out, completed during site visits, or left at the property if no one was home. Survey procedures are summarized in the flow diagram in Figure 6.

SURVEY PROTOCOL

We conducted surveys via telephone whenever we had current telephone numbers. If after 3 - 5 calls we still had not reached anyone at the address, we conducted a site visit. (In some cases, >10 calls have been made to a property without reaching anyone.) Two staff members went together on site visits although only one went up to the door. The questionnaire was filled out on site if the owner or renter was home. In cases where no one was home during a site visit, we left an introductory letter (Appendix B), a questionnaire, and a stamped, self-addressed envelope at the property. If no response came within two weeks and additional telephone calls still did not find anyone at home, we made a second site visit if time permitted. Site visits were also made at those properties where we had incorrect telephone numbers, where the telephone number was unlisted, or where there was no telephone installed. In a few cases where properties were owned by out-of-town (absentee) owners, we mailed materials to the owner's address.

3.0 RESULTS

The results of the well water user survey are summarized in Table 1. A total of 3,291 properties were surveyed during the study. This list is shorter than original estimates because we consolidated large holdings owned by one owner, in cases where the owner could verify the water use status of the entire property. Properties consolidated in this way included, a) Bloomington Housing Authority holdings, b) trailer parks, c) apartment complexes, and d) condominium projects.

Of the total number of properties surveyed, 184 (5.6%) are currently using groundwater wells and an additional 123 properties have wells but are not using them at this time. The Bennett's Dump area had the largest number of well users but the Neal's Landfill area had the highest percentage of properties with wells in use (35.3%). Addresses, names and telephone numbers for all well users are listed by site in Tables 2-5.

Tables 6-9 list properties having wells that are not currently being used. Many of these are capped and sealed. This list is likely incomplete as respondents who answered that they were not currently using a well did not always volunteer that they had an old well on the property. However, this list could be useful if any of these old wells are opened up in the future, or if additional groundwater monitoring locations are needed.

As with any public participation survey, a small number of people refused to cooperate, even after we explained that the program was in their best interest. These refusals varied from hanging up the telephone on our staff, shutting the door in their faces, and in one case, one of our surveyors was struck physically by a respondent. The properties where respondents refused to cooperate or where the survey information is incomplete are listed in Table 10. Because of the lack of cooperation, we

could not verify whether there was an operating well on the property or even the owner's name. A number of respondents volunteered well information but then would not confirm their address or did not know the name of the property owner. These are also included in Table 10.

As of this date, 180 property owners could not be reached by telephone and failed to return questionnaires left at their door or mailed to them. At a number of these properties, questionnaires were dropped off on two different site visits. We have distinguished these as "failures to respond" and they are listed in Table 11. We suspect that in cases where no well exists, some property owners didn't bother with filling out the questionnaire. Since some of these questionnaires may yet be returned, this list may require updating.

A small number of property owners could not be located using any of our sources. These may be cases where the owners have moved without leaving a forwarding address, did not update their address with the county government, or

where the county records were in error. Whatever the reason, a total of 51 property owners could not be located. These are listed in Table 12.

The complete list of all 3291 properties that we contacted in the four study areas is included in Appendices C - F. These lists originally served as our working lists in the field and although the names and addresses are accurate, the columns are not all filled in for this report. For example, every site was field verified but we did not feel it was time efficient to type in X's for each site in this column. More detailed information on specific sites is included on the individual questionnaires for all properties contacted which are kept in loose leaf notebooks by site. These individual survey forms include additional information and comments concerning the properties, including the number of telephone calls made to an owner and when they were made, the dates of site visits, the dates when letters were sent out and the name of the person who gave us the information.

4.0 DISCUSSION

Previous well user information collected by Blasland and Bouck Engineers, by the Indiana State Board of Health, and by Westinghouse was used as a check to confirm our lists. Several variations should be noted. The relatively large number of mobile home trailers in Monroe County caused some problem in tracking down addresses from the preliminary lists. We found several cases where trailers had been recently moved from rural lots and when they move, there is no longer a numbered address at the location. New addresses were added to our list in this same way by trailers being moved to new properties in the study areas. Because of this, it is difficult to keep track of mobile home addresses.

We also used well logs that were previously collected as a check on the information that property owners gave to us. In many cases, the well log indicated that there was a well on the property, but the owner maintained that there was not. Since we had no other mechanism at our disposal to verify this we had to assume that the current owner was indeed on city or rural water and was unaware of the existence of a well on the property. These cases were added to Tables 6 - 9 (wells not in use).

A number of survey forms have not been returned to us by property owners. We will forward these to Westinghouse as they come in.
