

B. In the case of a claim, action, suit or proceeding by or in the right of the corporation to procure a judgment in its favor, only if the Board of Directors or the Executive Committee, acting by a quorum consisting of directors who are not parties to such claim, action, suit or proceeding, shall find, or independent legal counsel (who may be the regular counsel for the corporation) shall render their opinion that the director, officer or employee acted in good faith in what he reasonably believed to be the best interests of the corporation or such other corporation, as the case may be, provided, however, that no indemnification under this subdivision B shall be made with regard to (i) matters as to which any such director, officer or employee shall be finally adjudged to be liable for negligence or misconduct in performance of duty; or (ii) amounts paid, or expenses incurred, in connection with the settlement of any such claim, action, suit or proceeding, without the approval of a court of competent jurisdiction.

For the purpose of Subdivision A of this section, the termination of any claim, action, suit or proceeding, civil, criminal or administrative, by judgment, settlement (whether with or without court approval) or conviction or upon a plea of guilty or of nolo contendere, or its equivalent, shall not create a presumption that a director, officer or employee did not meet the standards of conduct set forth in said subdivision A.

Section 3. Expenses incurred with respect to any claim, action, suit or proceeding of the character described in said

Section 1 may be advanced by the corporation prior to the final disposition thereof upon receipt of an undertaking by or on behalf of the recipient to repay such amount unless it shall ultimately be determined that he is entitled to indemnification.

Section 4. The rights of indemnification provided herein shall be in addition to any rights to which any such director, officer or employee or other person may otherwise be entitled by contract or as a matter of law.

Section 5. If any of the above provisions for indemnification of officers, directors or employees are invalid or unenforceable under New Jersey law, said provision shall be deemed severable, and shall not render the other provisions invalid or unenforceable.


