Dear Mr. Struhs:

The U.S. Environmental Protection Agency, in cooperation with the Michigan Department of Environmental Quality, has overseen Georgia Pacific LLC's completion of a response action to address contamination at the Allied Paper Inc./Portage Creek/Kalamazoo River Site in Allegan and Kalamazoo Counties, Michigan ("Site"). This work was conducted pursuant to an administrative order on consent (2007) ("AOC"). The response actions were taken under authority of the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, as amended (CERCLA), 42 U.S.C. §§ 9601-9675. Prior to undertaking the response actions, EPA determined that there was a release or threatened release of hazardous substances from the Site. The EPA undertook the response actions using monies authorized by CERCLA, as amended.

During the response, EPA oversaw the respondent's removal actions at the Site ("Plainwell Impoundment Removal"). The removal included the following actions:

- Excavation and/or dredging of submerged sediments, river banks and floodplain soils in the Plainwell Impoundment Area in accordance with the performance standards and at the locations specified in the Action Memorandum and the Work Plan;
- Cut-back and stabilization of river banks;

- Disposal of all PCB contaminated material;
- The use of excavated clean soils as cover;
- Re-vegetation of excavated floodplain areas; and
- Monitoring during the implementation of the Work and for three years subsequent to receipt of EPA's Notice of Completion of Work.

EPA has incurred response costs associated with its oversight of the removal action referenced above. Pursuant to the 2007 AOC, EPA billed respondents for a portion of EPA's annual oversight costs for the removal action. *See* ¶ 36 of the 2007 AOC ("U.S. EPA shall bill and Respondents shall pay Future Response Costs in an amount not to exceed \$300,000 during the first year subsequent to the Effective Date of the Settlement Agreement. For each year after the first anniversary date of this Settlement Agreement, U.S. EPA shall bill and Respondents shall pay Future Response Costs in an amount not to exceed \$325,000 . . .") The approximate EPA response costs that have not already been recovered under the AOC are \$551,605.49. The March 20, 2009 and August 31, 2009 bills, including itemized cost summaries, for these costs are enclosed.

As explained in EPA's November 24, 2010 general notice letter sent to you, the information available to EPA indicates, among other things, that The International Paper Company is potentially responsible for the release, or threat of release, of hazardous substances from the Site as a previous owner and/or operator of the Site where The International Paper Company is a corporate successor to St. Regis Paper Company and Bryant Paper Company which were owners and operators of the paper mills that disposed of PCBs and PCB-containing material at the Site. Thus, EPA believes that you may be liable for the payment of all costs incurred by EPA in connection with the Site. Partial payments will not release the payor of liability for payment of the rest of the costs that are owed to EPA. Limiting language on the check or in accompanying letters will be considered to be advisory only and will not be considered as placing conditions on the amount paid or as limiting liability on other costs demanded in this letter.

Such payment must be made by a cashier's or certified check made payable to the "U.S. EPA Hazardous Substance Superfund", which is established by the Internal Revenue Code, 26 U.S.C. § 9507, and administered by EPA. Please send your check to U.S. EPA, Superfund Payments, Cincinnati Finance Center, P.O. Box 979076, St. Louis, Missouri, 63197-9000. Place the following Site Identification Number on the check: **(SSID # 05 9B)**. Please send a copy of your payment check to Thomas Marks, Chief, Enforcement Services Section 1 (SE-5J), U.S. EPA, Region 5, Superfund Division, 77 West Jackson Boulevard, Chicago, Illinois 60604, and to the Office of Regional Counsel (C-14J), U.S. EPA, Region 5, 77 West Jackson Boulevard, Chicago, Illinois, 60604.

We hereby demand that you make restitution by payment of the amount in this letter expended by the agency in connection with the Site pursuant to authority of CERCLA, as amended. Pursuant

to Section 107(a) of CERCLA, as amended, interest shall begin accruing as of the date of this demand, if payment is not received within thirty (30) calendar days of the date of this letter.

If you desire to discuss your liability with EPA, please contact Leslie A. Kirby-Miles, Associate Regional Counsel, in writing no later than thirty (30) calendar days after the date of this letter. She may also be reached by phone at 312-353-9443. If we do not receive a response from you within this time frame, EPA will assume that you have declined to reimburse the Fund for the Site expenditures, and pursuant to CERCLA, EPA may pursue civil litigation against you to recover all of its costs, with interest.

The name of the other PRP receiving this request for payment is enclosed with this letter to facilitate organization among the identified parties concerning payment. PRPs should attempt to work out an allocation among themselves to apportion costs; however, whatever allocation system the PRPs develop among themselves, EPA considers the PRPs jointly and severally liable for the amounts demanded in this letter until all costs are reimbursed or an appropriate settlement is achieved pursuant to Section 122(h) of CERCLA.

The enclosed billing is for the recovery of costs incurred by the U.S. Environmental Protection Agency (EPA) for oversight activity, performed under the authority of the Comprehensive Environmental Response Compensation and Liability Act (CERCLA) as amended, for the period 02/21/2007 through 02/21/2008. These costs were incurred for the Allied Paper site during the first year subsequent to the start of the removal action. Pursuant to paragraph 36 of the settlement agreement between EPA, Millennium Holdings, LLC and Georgia-Pacific, LLC (VW-07-C-863), EPA is due \$300,000.00. 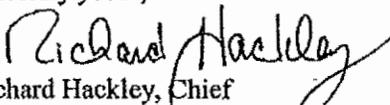

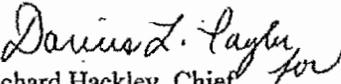
