# Sylvia's Place planning for big month of April

April is National Prevent Child Abuse Awareness Month, and Sylvia's Child Advocacy Center Executive Director Kassie Frazier is in full swing to get the word out. She has big plans to use the occasion to drive the issue home within the county.

said Frazier recorded 204 cases in 2016 and already has logged 60 in

That number is an increase from last year as Frazier said January and February are traditionally slow months for reporting abuse.

"We talked about the increase in those months as a group," Frazier said. "I really think it's the awareness and not that so many more (cases) are happening. I think more people are talking about it."

Each Boone County town has agreed to hang prevention banners for all of April. An ugly tie campaign with the motto "Nothing Is As Ugly As Child Abuse" will begin April 1. Frazier will speak at the Boone County Community Foundation Leadership Day, which is also BCCR Law Enforcement Day, on April 19.

Funded through SCAC and Prevent Child Abuse Boone County, Frazier said, the purple banners will be an important reminder for each person who sees them throughout the month. A 24-hour hotline number is displayed, along with the phrase "Use your heart, not your hands.

"I want all towns to feel as connected as possible, and they (the banners) will go up in every town to show that we're all in this together," Frazier said.

The ugly tie drive has been designed to unite different county leaders in the fight against child abuse. as runners/walkers dress

Frazier will travel around the county to get pictures of the leaders wearing ugly ties, to display on the center's social media sites. For those wishing to send in ugly tie pictures in support, Frazier said they should use the hash tag #TieOneCampaign and tag the center's Twitter account @boone\_

"Our goal with this campaign is to show how many people in our community will stand together to stop abuse," Frazier said.

Frazier will speak during the BCCF Law Enforcement Day from 9 a.m. to 5 p.m. April 19, at Sylvia's Place, Lebanon's Municipal Building and the Boone County Sheriff's Office. Several of the county's law enforcement leaders, including Sheriff Mike Nielsen, will attend.

Cost of the 5K run/walk will be \$30 per adult and free to kids 13-and-under due to sponsorships from the Lebanon Police Department, Boone County Guardian Ad Litem, and Zionsville

**EPA Begins Review** of Envirochem Corp. Superfund Site Zionsville, Indiana

U.S. Environmental Protection Agency is conducting a five-year review of the Envirochem Corp. Superfund site 865 S. State Road 421 near Zionsville. The Superfund law requires regular checkups of sites that have been cleaned up - with waste managed on-site - to make sure the cleanup continues to protect people and the environment. This is the fourth five-year review of this site.

EPA's cleanup of the site included soil vapor extraction to remove volatile organic compounds; a multilayer cap to reduce water infiltration and to minimize contact with contaminated materials; a groundwater collection and treatment system; long-term monitoring; and limits on use of and access to
