The purpose of this letter is to notify you of potential liability, as defined by Section 107(a) of the Comprehensive Environmental Response, Compensation, and Liability Act, as amended (CERCLA), 42 U.S.C. Section 9607(a), that you may incur, or may have incurred with respect to the above referenced site. This letter also notifies you of potential response activities at the site, which you may be asked to perform or finance.

The United States Environmental Protection Agency (EPA) has documented the release of hazardous substances, pollutants or contaminants, at the Mosley Road site. The site is located in Oklahoma City, Oklahoma, at 36th Street and Mosley Road. This site was originally called the "A-1 Landfill". It has been operated until recently as a sanitary landfill by Waste Management of Oklahoma.

EPA is considering spending public funds to control these releases. Unless EPA reaches an agreement under which a potentially responsible party (PRP) or parties will properly perform or finance such actions, EPA may perform these actions pursuant to Section 104 of CERCLA, 42 U.S.C. Section 9604.

EPA has evaluated information in connection with the site concerning persons who may be associated with it. Based upon this evidence, EPA believes that you may be a potentially responsible party with respect to this site. PRPs under CERCLA include current and former owners and operators of the site as well as persons who arranged for disposal of hazardous substances found at the site, or persons who accepted hazardous substances for transport to the site.

Under Sections 106(a) and 107(a) of CERCLA, 42 U.S.C. Sections 9606(a) and 9607(a), Section 7003 of the Resource Conservation and Recovery Act, 42 U.S.C. Section 6973, as amended (RCRA), and other laws, PRPs may be obligated to implement response action deemed necessary by EPA to protect the public health, welfare or the environment, and may be liable for all costs incurred by the government in responding to any release or threatened release at the site. Such actions and costs may include, but are not limited to, expenditures for conducting a Remedial Investigation/Feasibility Study (RI/FS), and other investigation, planning, response and enforcement activities.

Based on information that has been gathered to date, it is now necessary to conduct a remedial investigation on the nature and extent of contamination at the site. The remedial investigation will be followed by a feasibility study to evaluate possible remedial actions to remove, eliminate and/or contain any hazardous substances, pollutants and contaminants on or emanating from the site. It will also be necessary to prepare an endangerment assessment describing the nature and extent of any threat posed to human health or the environment.

This letter serves two basic functions. First, it notifies you that a 60-day period of formal negotiations with EPA automatically begins on March 30, 1989. Second, it provides general and site specific information to assist you in these negotiations.

As provided under Section 122(e)(2) of CERCLA, 42 U.S.C. Section 9622(e)(2), you will have 60 days from the start of the negotiation period in which to make an offer to conduct, or finance, the Remedial Investigation/Feasibility Study (RI/FS). During this negotiation period, EPA is prohibited from conducting the RI/FS. If a "good faith offer" is received within 60 days, negotiations may be extended for an additional 30 days. If settlement is reached between EPA and a PRP within the 90-day moratorium, the settlement will be embodied in an Administrative Order on Consent. Under CERCLA 122(e)(5), EPA is not precluded from undertaking a response or enforcement action during this period if EPA determines that a significant threat to public health or the environment exists.

A "good faith offer" must be in writing, and must specify your qualifications and willingness to conduct, or finance, the RI/FS. The offer must also include a demonstration that your company has the capability to finance the RI/FS (i.e., identify the process to be used to select and pay a firm to conduct the RI/FS); a statement on how your company plans to proceed with the work; and a statement of your company's willingness to pay oversight costs. A list of the other parties who have received this notice is enclosed.

EPA will arrange a meeting to discuss the ramifications of this notice, should you so desire. If you wish to arrange a meeting, contact Alan Tavenner at the telephone number given below.

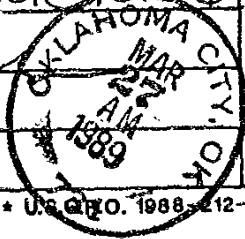
