#### **Extending Pilot for Open Technical Meetings**

Over the last few months, we piloted a new approach to public engagement in Butte based on feedback from the community. We have piloted opening three types of technical meetings for public observation: remedial design/remedial action, materials management, and groundwater monitoring meetings.

So far, we have had three remedial design/remedial action meetings. Outside of a few technical challenges, we have received positive feedback from those attending or observing. Given this feedback, we are going to continue this pilot for the next six months and will work on scheduling all three types of technical meetings in the new year. The invites and meeting links to these technical meetings will be sent out from EPA via our list serv and announced on our website.

#### **EPA's Meaningful Involvement Policy**

On November 16, 2023, EPA announced the release of the draft policy, "<u>Achieving Health and Environmental Protection Through EPA's</u> <u>Meaningful Involvement Policy</u>," for a 60-day public comment period. This policy updates <u>EPA's 2003 Public Involvement Policy</u> that guides EPA staff to provide meaningful public involvement in all its programs and regions. The revised policy builds on this premise and updates EPA's public involvement approach.

# West Side Soils Operable Unit Update

EPA is currently reviewing the draft remedial investigation, a human health risk assessment, and ecological risk assessment. Once finalized, the agency will work to complete the Feasibility Study which will develop and evaluate remedial alternatives. While we can't make riskrelated decisions until then, the existing data show that metals concentrations are not high enough to warrant a time-critical removal under CERCLA authority.

The West Side Soils Public Database contains a brief technical writeup about the validated soil and well data, a fact sheet, Excel\* files with analytical results for each sample collected, and figures that show the sample locations. Results for samples collected on individual properties were sent to the property owners, and phone calls were made to confirm receipt and answer any questions. Affected property owners will continue to be updated as new data is collected and validated. The EPA project manager provided an overall project update and sampling results overview to both the BSB Council of Commissioners and the Board of Health, on two separate occasions, earlier this year.
