## What is the TCT?

- The Portland Harbor Technical Coordination Team (TCT) was formed with the execution of the 2001 Memorandum of Understanding (MOU)
  - The parties of the MOU include Federal, State, and Tribal governments and agencies representing those governments
  - All of these parties have recognized rights and authorities under the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA)
  - The purpose of the TCT is to provide a framework for coordination and cooperation in the management of the Site to optimize federal, state, and tribal expertise

## Why did the TCT Form?

- The Portland Harbor site was listed on the National Priorities List (NPL) in 2000
- Superfund sites are extremely complicated and coordination between Federal, State, and Tribal entities is required for a successful cleanup
- Federal, State, and Tribal expertise lies within different areas and a framework is needed to optimize those resources in the CERCLA process
- EPA upholds its tribal trust responsibility



### What does the TCT do?

- Coordination to optimize federal, state and tribal expertise:
  - The TCT provides a forum for meaningful Federal, State, and Tribal engagement in the Portland Harbor Site from investigation to remedial action

#### • Examples of TCT work:

- Review, discuss, and comment on key documents, reports, permits, and agreements.
- Identify roles and responsibilities for upcoming work elements

#### Confidentiality

The TCT agreement has a section on confidentiality because:

- Some topics or documents that are reviewed may be 'privileged and confidential' due to project status or ongoing negotiations
- Final documents and agreements are made public
